ABOUT NLUO

National Law University Odisha, the prestigious institution is situated at the confluence of the Mahanadi and the Kathajodi rivers in the Millennium City or the Silver City of Cuttack. This legal temple was established by Act IV of 2008 by the Odisha State Legislature. The institution since its inception in 2008 has continuously endeavored towards thriving excellence and producing bright minds in the legal and other associated arenas. It has painted a blazing picture of cultural diversity as being a pan-India institute and equally treating all students to realize their true potential. Academic as well as non-academic co-curricular activities have been given proportionate importance for the overall development of the students.

CAMPUS INFRASTRUCTURE

The NLUO campus is spread over 50 acres. It is designed to be eco-friendly, incorporating features such as rain-water harvesting measures. The state-of-art campus boasts of an Academic Block, well-equipped hostels and the Administrative Block. The Academic Block is fully air-conditioned. The campus has football and cricket grounds, a thousand-seater auditorium/amphitheatre, food courts, gym and other sports facilities. A dedicated library was also inaugurated recently. The lecture halls are airy, spacious, well-lit, and comfortable. They feature advanced audio-visual equipment, including LCD projectors, dedicated sound systems, and electronic blackboards (which automatically generate printouts of what has been written on them).

Courses are designed in order to make optimum use of the equipment; as a result, PowerPoint presentations, film screenings, and other multimedia techniques form an integral aspect of NLUO's undergraduate and postgraduate curricula.

The University has Basketball, Volleyball, Badminton, and Tennis Courts. In addition to this, equipment for indoor games like table tennis and carom are already present in all the hostels of the university.

GRADING SYSTEM

The grading system of NLUO comprises of a rigorous system of written examinations, projects and vivas, documentaries and surveys as well as mootings. Each student is marked out of a total of 100 marks for every subject and each student can take six subjects each semester, making 600 marks the total evaluation score.

Research Projects and Collaborations

Odisha State Child Labour Survey

Seeking total elimination of child labour in the state, the Odisha government has formulated a “State Action Plan for Elimination of Child Labour”. As a part of the said initiative, the Labour Commissioner has also requested NLUO to finalize a team of researchers and professionals who would work with the Labour Department not just for the survey but also in the long run for various intensive activities for elimination of child labour in the State of Odisha.

Analysis of the Functioning of Lok Adalats in Eastern India

This project is aimed at studying the prevalent state of affairs as regards the functioning of Lok Adalats in the Eastern Region of India and then scrutinizing the performance of Lok Adalats in terms of statistical parameters to have a more comprehensive understanding of the structural capacities and deficiencies.

Start-Up Odisha

The main objective of the MOU is to provide all types of legal assistance to Startup Odisha, conduct seminars, workshops, Startup Weekends, training Programmes in collaboration with Startup Odisha, Collaborative research and teaching, research findings, and publications. The terms and conditions of the MOU will be executed through Lextech – Centre for Law, Entrepreneurship and Innovation, NLUO.

NYAAYA

The Legal Aid Society, NLUO in pursuance of our objective to serve society, especially in these uncertain times has collaborated with NYAAYA (Vidhi Centre) on their newly launched initiative. Nyaaya has launched a COVID Whatsapp helpline number to assist people by answering any legal questions that they may have during the existing crises. The purpose of this helpline is to empower people with the knowledge of their rights and enable them to take action.

Police-Academia Interaction Forum (PAIF)

The forum would focus on facilitating a mutually beneficial interaction among police officials and academics and students. It would provide the students practical exposure to the workings of the police and real-life exposure to investigation and law enforcement through academic interactions and internships in various departments of the state police.

Addressing Domestic Violence in Odisha Through Institutionalised Response Protocols

In July, 2023, National Law University Odisha, Cuttack entered into an agreement with the Netherlands Embassy to implement a project titled Addressing Domestic Violence in Odisha through Institutionalised Domestic Violence Response Protocols. The Project is funded by the Human Rights Fund. The project is for a period of two years and is led by Prof. Rangin Pallav Tripathy and Assoc. Prof. Suman Dash Bhattamishra. The project aims at establishing institutionalized domestic violence response protocols in the state of Odisha to enhance the victims’ access to justice.

Analysis of Performance Appraisal and Promotions of Subordinate Judiciary in India

This project is aimed at conducting a comparative analysis of the performance appraisal mechanism and schemes of promotion in relation to the judges of subordinate judiciary in different states. In addition to that, the research project also aims to identify the prevalent best practices and model mechanisms in relation to the performance appraisal and schemes of promotion of the judges (of subordinate judiciary) in different states and then make recommendations on the possibility of implementing uniform standards and policies concerning performance appraisal and schemes of promotion of the judges in different states.

Litigation Management in Higher education in Odisha

This project is run by National Law University Odisha in collaboration with Department of Higher Education, Government of Odisha. Though huge numbers of cases are filed in courts every month, there are a record number of pending cases in many departments. This project work commenced on February 20, 2017 and funded by World Bank will help the Government of Odisha in monitoring all the cases ongoing against them in addition to better utilisation of resources.

Drafting of Rules for Protection of Consumers

National Law University Odisha has completed a project entrusted by Food Supplies and Consumer Welfare Department, Government of Odisha, with the task of framing the Draft Consumer Protection Rules, 2020 for State of Odisha under the provisions of new Consumer Protection Act, 2019. The approved project grant was Rs.9,01,780/-. An expert team of University constituting of Faculty members and students members of Centre for Consumer Rights along with external experts from the field of Consumer Law have worked for the project. The University has submitted draft rules to the Government of Odisha.

Women Safety Audit in Association with NCW

The National Commission for Women along with National Law University, Odisha is conducting a Women Safety Audit project in Asansol, a city situated in West Bengal. Women in urban areas face violence and harassment due to poor urban design, inadequate public facilities, and regressive social attitudes. The audit aims to understand what makes public spaces safe, identify reasons for poor safety, and create a roadmap for building secure cities by proactively addressing these issues. The purpose of this study is to evaluate the safety concerns encountered by women within the city. The findings will be used to make recommendations for enhancing law enforcement efforts, improving infrastructure design, and strengthening community participation.

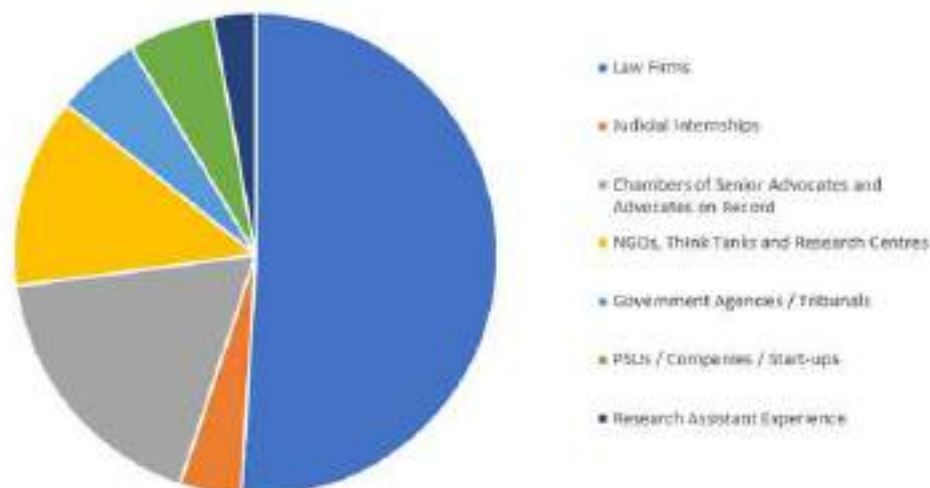

RECRUITMENT PROCESS

INITIAL COMMUNICATION WITH THE RECRUITER

The Recruitment and Coordination Committee, NLUO, shall send invitations to recruiters along with the placement brochure and relevant information. Alternatively, an organisation may approach the Recruitment and Coordination Committee by writing to recruitment@nluo.ac.in.

PRE-PLACEMENT TALKS

Recruiters are invited to organize Pre-Placement Talks at the University for students who are interested. During these sessions, valuable information such as organizational profiles, career advancement opportunities, compensation packages, and more can be shared. These presentations can take place ahead of the Pre-Interview Screening process.

PRE-INTERVIEW SCREENING

Recruiters have the option to carry out a Pre-Interview Screening, which may include group discussions or written tests at any point before the actual interview day. Recruiters have the flexibility to establish their own screening policies to shortlist candidates. In instances where a Recruiter doesn't specify a particular Pre-Interview Screening method, the curriculum vitae of all interested students will be shared with the Recruiter.

FINAL INTERVIEW

Following the conclusion of the Pre-Interview Screening, the Recruiter will prepare the Final Interview List and share it with the RCC at least 48 hours before the scheduled interview, along with a list of waitlisted candidates. If any selected applicant from the Final Interview List is unavailable for the interview, the Recruiter may choose to interview waitlisted candidates if deemed appropriate. If the Recruiter does not have a Pre-Interview Screening procedure, the list of interested students will automatically serve as the Final Interview List.

DISCLOSURE OF OFFERS

The RCC will announce the results collectively at the end of the day to guarantee impartiality among recruiters. Recruiters must reveal the outcomes of their Final Interviews and any offers extended to applicants solely through the RCC, and this information will be conveyed in a sealed envelope.

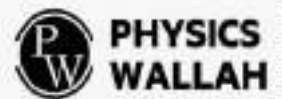

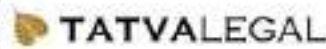
