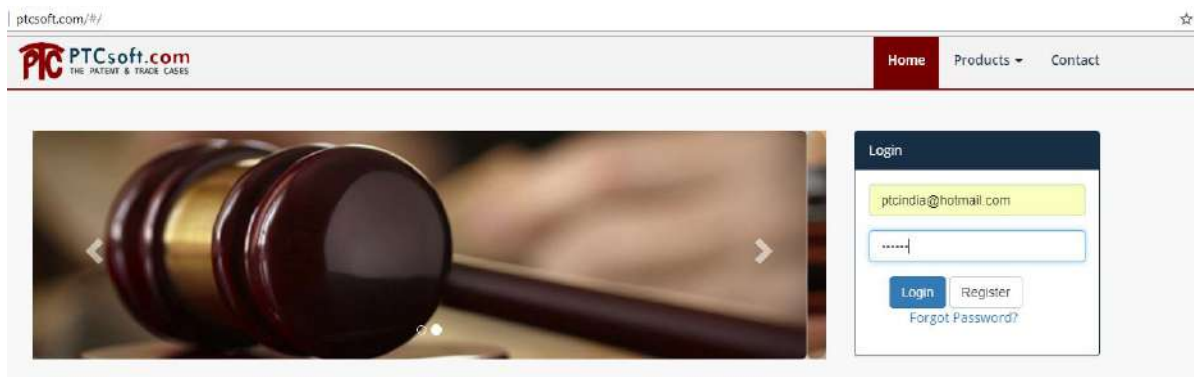

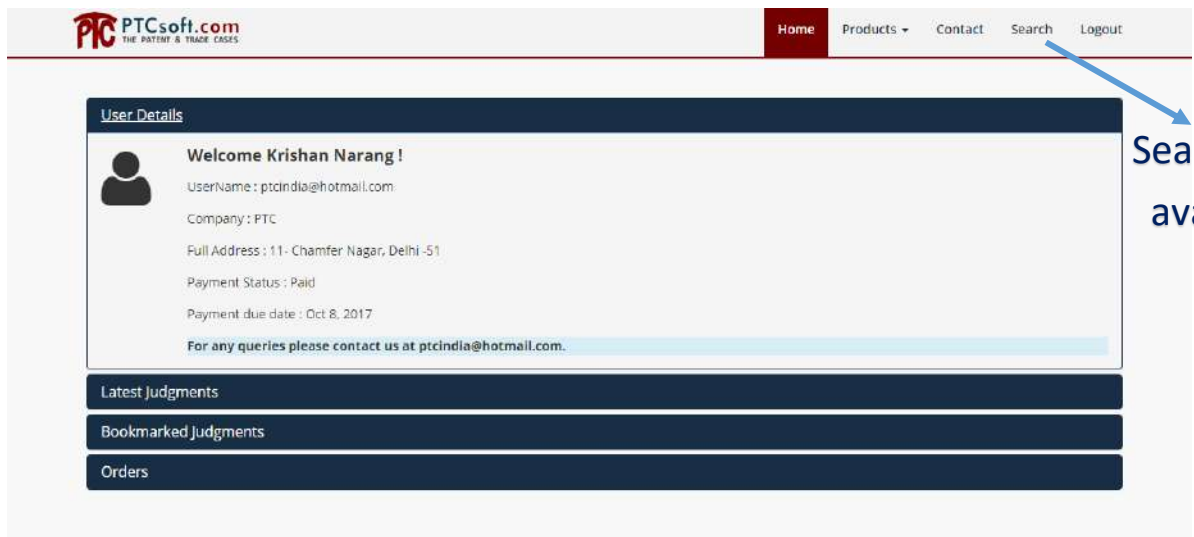
Login:



Section 17(b) - Injunction - Violation of copyright - Threatening - An Annual Day Event organised by the plaintiffs - Defendant No. 2 was assisting plaintiff No. 2 towards publication of the book - Book was to consist of photographs depicting different health issues - Defendant No. 1 took photographs - As per the terms of the engagement of defendant No. 1 was agreed not to deliver any of the said photographs to anyone else - Defendant No. 2 has failed and neglected to handover the necessary photographs to plaintiff No. 2 and has illegally demanding to join the teacher training programme and stay at the Yoga Centre with a remuneration of at least Rs. 1,00,000/- for her to obtain a work permit - Copyrights of the plaintiffs are being threatened to be violated by defendant No. 2 - Held, a clear case of threat to the rights of the plaintiff under the Copyright Act are made out - Decree of permanent injunction is passed in favour of plaintiffs.

The First option available is “Free Word Search”- you can search for any phrase or word in the judgment.

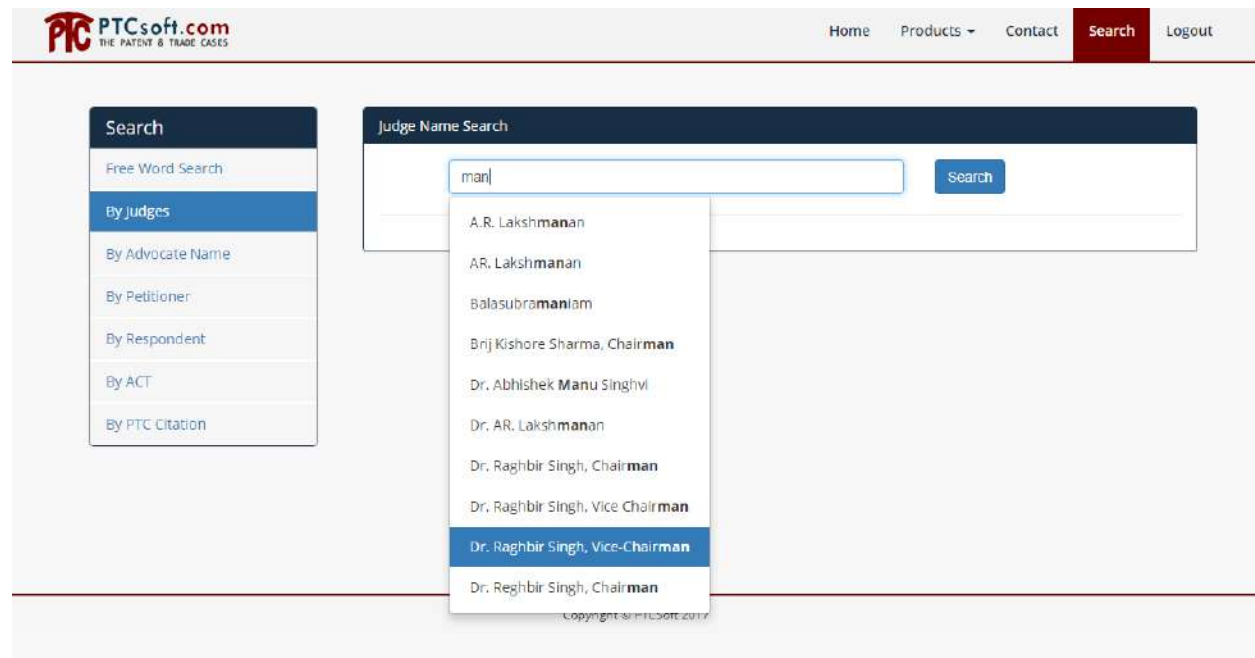
Exact Phrase will look for complete sentence or phrase in the judgment and if you want to search for some words irrespective of their order in the judgment use “All words” search.

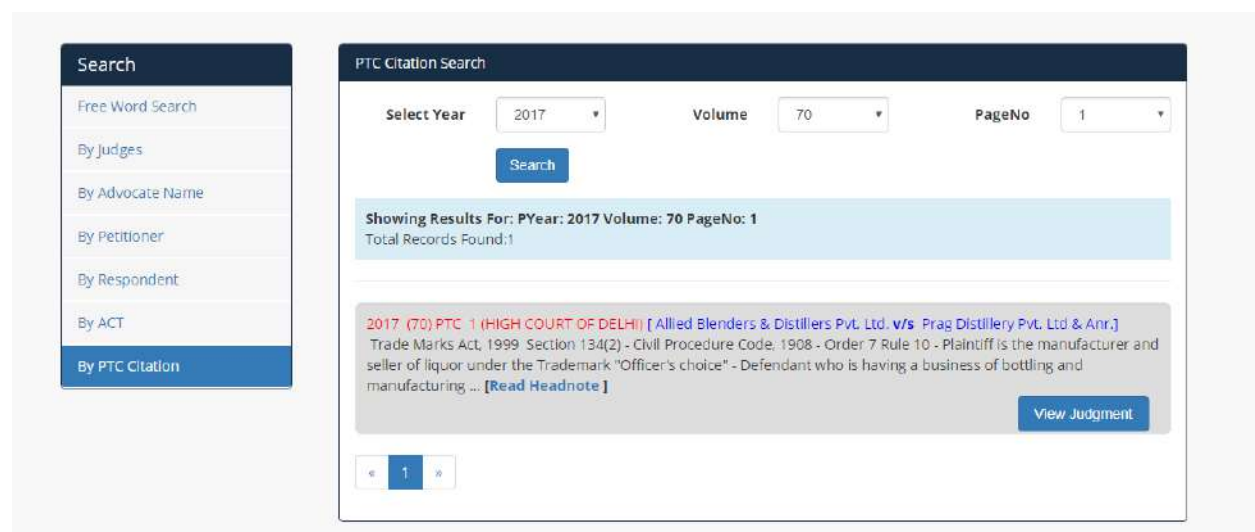
User can search with the names of the judges, respondent or advocates involved.
