The following criteria will be applicable for the selection of gold medalist for Overall Best Performance (U.G), Outstanding Leadership (U.G) and Subjects for the batch of 2011-16.

Overall best performance (U.G)

- 1. Participation and performance in moot court competitions
- 2. Participation and performance in literary and debating competitions
- 3. Participation and performance in sports competitions and events
- 4. Participation in student committees of the university
- 5. Participation and presentation of papers in national and international seminars/conferences
- 6. Publications in national/international journals, magazines
- 7. Participation and performance in cultural events
- 8. By performance, whether received any prize / award / honourable mention etc as part of team and/or as individual achievement. (Information with such proofs or details that can be verified).
- * Information which cannot be verified may not be considered.
- ** Cut off mark: 7.00 GCPA
- *** Students should not have any repeat / back / carryover paper in her/his entire 5 year carrier.

Outstanding leadership (U.G)

- 1. Name of the University committees for which you have been convener or coconveners in five years in the NLUO.
- 2. Year in which you were convener/co-convener.
- * Information which cannot be verified may not be considered. So it is requested to provide the information with sufficient detail
- ** Cut off mark: 6.00 GCPA
- *** Students should not have any repeat / back / carryover paper in her/his entire 5 year carrier.

Criteria for subject wise Gold Medals are as follows:

- i) For <u>Constitutional Law (B.A., LL.B / B.B.A., LL.B:</u> A sum of highest marks in the paper Constitutional Law-I, Constitutional Law-II and Administrative Law will be taken for awarding of gold medal. Further it will be taken into consideration that the gold medalist doesn't have any repeat / back / carry over in her / his entire 5 year academic carrier.
- ii) For <u>Criminal Law (B.A., LL.B / B.B.A., LL.B:</u> A sum of highest marks in paper Indian Penal Code-I, Indian Penal Code-II and Code of Criminal Procedure will be taken for awarding of gold medal. Further it will be taken into consideration that the gold medalist doesn't have any repeat / back / carry over in her / his entire 5 year academic carrier.
- iii) For Commercial Law (B.A., LL.B / B.B.A., LL.B: A sum of highest marks in paper Corporate Law-I, Corporate Law-II and Insurance Law will be taken for awarding of gold medal. Further it will be taken into consideration that the gold medalist doesn't have any repeat / back / carry over in her / his entire 5 year academic carrier.
- iv) For Intellectual Property Right Law (B.A., LL.B / B.B.A., LL.B: (IPR-I and IPR-II will be taken for awarding of gold medal. Further it will be taken into consideration that the gold medalist doesn't have any repeat / back / carry over in her / his entire 5 year academic carrier.
- v) For <u>Banking Law (B.A., LL.B / B.B.A., LL.B)</u>: A sum of highest marks in paper Banking Law will be taken for awarding of gold medal. Further it will be taken into consideration that the gold medalist doesn't have any repeat / back / carry over in her / his entire 5 year academic carrier.

Gold Medals would not be given to students who have any repeat/back paper or carry forward exams.
