TERMS AND CONDITIONS:

1. **Scope of works:** Details enclosed at schedule as Annexure-III.
2. Bidder(s) can inspect the Items awaiting disposal between 10.00 A.M. to 4.00 P.M. on working days at NLUO premises in regard to the conditions, quality etc of items and satisfy themselves before submitting their offer by the date and time specified.
3. Overwriting or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
4. It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same in full, deviations from the terms and conditions as given in this are not permitted. Any such conditional bid and/or telegraphic bid is liable to be rejected. No counter terms and conditions shall be accepted.
5. Right to include, notify, or alter any of the bid conditions already stipulated is reserved by the Vice Chancellor, NLUO, Cuttack.
6. All goods will be sold on "**AS IS WHERE BASIS**". Bidder will be deemed to have been on the clear understanding that they have satisfied themselves fully in regard to the conditions, quality and quantity of unserviceable items proposed to be auctioned.
7. In the event of non-removal of the materials the EMD of the Successful bidder will be forfeited and he will not be allowed to participate in future for such sale.
8. The successful bidder whose bid will be accepted shall have to deposit the offered amount within 05 working days & to lift the material from NLUO premises failing which the offer will be cancelled & EMD will be forfeited.
9. If the bidder fails to remove the materials within the time limit, the ground rent @ 1% of the bidding amount will be charged for each day till removal of the article up to maximum of 10% of contract value.
10. The Vice Chancellor reserve the right to accept or reject any or all of the bids without assigning any reason thereof.
11. If two bidders quote equal rate, then final bidder will be selected through lottery.
12. Any expenses towards transportation & manpower etc. will be borne entirely by the successful bidder.
13. The bidder shall not be allowed to transfer, assign pledge or sub-contract its rights and liabilities under this contract to any company/firm/bidder without the prior written consent of this University.
14. The University reserves the right to terminate the contract at any time, if required.
15. In the event of failure to accept the offer of contract by the successful bidder for whatsoever reason(s), Earnest Money Deposit submitted by the bidder shall be forfeited. EMD of the unsuccessful bidders will be returned in due course of time.
16. The University shall not be responsible for any financial loss or other injury to any person deployed by the contracting firm in the course of their performing the duties to this University in connection with any contract with NLUO.
17. **Submission of quotation** - All sealed quotations must be dropped in the drop box kept at reception of Administrative Block, NLUO, Cuttack or to be sent by Speed /Registered Post on or before the scheduled date & time. The quotations received beyond scheduled date & time will not be acceptable at any circumstances. NLUO will not responsible for any postal delay. The quotation must be addressed to **The Registrar, National Law University Odisha, Kathajodi Campus, SEC - 13, CDA, Cuttack - 753015**, so as to reach within the specified period.
18. **Settlement of Disputes:** In the event of any dispute or differences between the National Law University Odisha and the bidder, arising out of non-supply of material or goods, not found as per specifications or any other cause whatsoever relating to the supply or purchase order, before or after the supply has been executed, shall be referred to the Vice-Chancellor, National Law University Odisha, Cuttack who may decide the matter herself or by constituting a committee or may appoint Arbitrator under the Arbitration and Conciliation Act, 1996.
