### **A. Job Description**

- To contribute to the [Centre for Child Rights-National Law University of Odisha's \(CCR-NLUO\)](#) agenda of research, dissemination, public advocacy and interventions to further the rights and well-being of children
- To contribute to and manage research and the uptake of the recommendations / findings / Standard Operating Procedures / protocols and policy outcomes from the researches
- To support curation of curriculum and jointly teach a course on Child Rights alongwith other colleagues / academics for the core university students and external professionals (if the need arises)
- To support building a rights' temper amongst children and society at large
- To represent CCR-NLUO at important events and support external engagement with key members of the judiciary, leaders, bureaucrats, policy makers, practitioners
- To support periodic training of key members of the judiciary, law and order, child welfare committees and juvenile justice boards for child protection
- To support public advocacy emerging from the researches to further the agenda of child rights and welfare
- To support resource mobilization and donor servicing efforts
- To work with colleagues at CCR and members of the NLUO (academic and non-academic) to further the agenda of CCR and NLUO

### **B. a. Eligibility requirements (essential):**

- i. A Master's degree with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned / relevant / allied academic area of 'Child Rights / Children's Welfare and Well-being' from an Indian university, or an equivalent degree from an accredited foreign university. Relaxations of 5% shall be allowed at the Master Level for the candidates belonging to Scheduled Caste / Scheduled Tribe / OBC (NCL) / Differently Abled Category for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% (or equivalent grade) and the relaxation of 5% to the above mentioned categories are permissible, based only on the qualifying marks without including any grace marks procedure

The candidate has been awarded a Ph.D. Degree in accordance with the University Grants Commission

- ii. Well-versed in English and Odia and ability to write documents in various formats. Please send two writing samples (published or under process of publication) as research articles / research papers, editorials, commentaries etc in academic journal / book chapter / newspaper or magazine of repute
- iii. Self-driven, collaborative and respectful
- iv. Entrepreneurial and resourceful in case of research ideas, research collaborations and fund-raising

- i. The candidate has 3-5 years of work experience in any academic institution (with teaching and / or research remit) / think-tank / non-profit (with programming / policy advocacy remit) / consulting firm /relevant project or department of the government
- ii. The candidate has some project management and research management prior experience
- iii. The candidate has demonstrated ability to write fund-raising proposals, donor reports, academic reports and event summaries
