- 5. **Specification:** The execution of work offered must be as per the specifications of the bid document.
- 6. Successful bidder will have to deposit 2% of biding amount as security deposit with in 02(Two)days of acceptance of the work order/LOI. This amount will be released along with final bill.

- 8. Liquidated Damage: Liquidated damage @ 1% on the value of work lagging behind per week of delay in delivery and completion shall be levied subject to maximum 15% of Contract price.

Submission of quotation All sealed quotations must be dropped in the drop box kept at reception of Administrative Block, NLUO at Cuttack or by Speed /Registered Post on or before the scheduled date & time. The quotations received beyond scheduled date & time will not be acceptable at any circumstances. NLUO will not responsible for any postal delay.
