- 3. Taxes if any as applicable will be deducted at source end.
- 4. **Time of completion**: Time is the essence of the contract. The entire scope of work shall be completed within 07 (Seven) days from the date of acceptance of the work order/LOI.
- 5. **Specification:** The execution of work offered must be as per the specifications of the bid document.
- 6. Successful bidder will have to deposit 2% of biding amount as security deposit with in 02(Two) days of acceptance of the work order/LOI. This amount will be released along with final bill.
- 7. **Terms of Payment**: The payment shall be made as per actual measurement/actual counting within 15(Fifteen) days from the date of submission of bill in all respect after successful completion of the work, deducting taxes as applicable.
- 8. **Liquidated Damage:** Liquidated damage @ 0.5% on the value of work lagging behind per week of delay in delivery and completion shall be levied subject to maximum 10% of Contract price.
- 9. Paying Officer: The Registrar, NLUO.
- 10. Submission of quotation All sealed quotations must be dropped in the drop box kept at reception of Administrative Block, NLUO at Cuttack or by Speed /Registered Post on or before the scheduled date & time. The quotations received beyond scheduled date & time will not be acceptable at any circumstances. NLUO will not responsible for any postal delay. The quotation must be addressed to The Registrar, National Law University Odisha, Kathajodi Campus, SEC 13, CDA, Cuttack 753015, so as to reach within the specified period.
