The matter concerning 10% EWS reservation was deferred due to fact that "the Government of Odisha does not have any reservation policy for reservation of seats in higher educational institutions in favour of students belonging to Economically Weaker Section (EWS) category". 4. Hon'ble Visitor expressed concern about delay in processing the proposal of the University for additional five(5) acres of land and impressed upon Advocate General to use his good office to coordinate with the competent authority for expediting the same. 5. Hon'ble Visitor underscored the necessity of getting allocation of funds from Government of Odisha for creation of seven(7) Specialized Departments in the University. Advocate General was requested to expedite the proposal pending with State Government in that regard.
