GC: 18/08	Any other Item with the permission of the Chair	<p>The Vice-Chancellor informed the members that Swiggy, a company providing food delivery services is providing home delivery of liquor on NLUO Campus.</p> <p>The Council was informed that in the last semester, an IMFL Shop right next to the campus was shifted after the matter was heard in the Collector's Court. The presence of the liquor shop had led to drinking issues on campus and also created an unsafe environment for students around the campus.</p> <p>However, the delivery of liquor on campus creates a very problematic situation with so many students of young age residing on campus.</p> <p>The Council unanimously resolved that delivery of liquor on campus is not permissible and should be stopped.</p> <p>It was resolved that letter should be sent to Swiggy asking the company to discontinue this practice.</p> <p>Letter should also be written to Local Municipality, DCP and Excise Department in this regard.</p> <p>The Council also resolved that necessary steps should be taken to stop the supply of narcotic substances in the in nearby areas.</p>
