ABOUT NLUO

The National Law University Odisha has made its mark as a university engaged in and committed to quality teaching and research in law within a short span of time. NLU Odisha is amongst the top-sixty Universities of the country which were granted authorisation to start new courses. In 2021, National Institutional Ranking Framework (NIRF) of MHRD, NLUO has received 9th rank amongst all NLUs and 14th rank amongst all Law Schools / Universities / Law Departments of Central and State Universities in India. It is now expanding and launching a new B. A. Specialisation Degree Programme from the Academic year 2023-24.

ABOUT THE B.A (LAW-2023)

In view of the National Educational Policy (NEP) 2020 suggesting 'job ready' courses with multiple entry and exit points. National Law University Odisha is offering B.A. (Specialisation) 2022 in five specialized vocational streams connected with law and legal profession. The programme aims to generate job ready skilled graduates. NLUO is offering B. A. specialization in the following five streams:

1. Legal Counselors
2. Legal Journalism
3. Advocacy
4. Legal Profession Assistants
5. Law and Entrepreneurship

This degree does not entitle the students to practice law but makes them eligible to join 3 year LL.B Course.



THE COURSE PATTERN

The students in each stream will study four compulsory papers and one optional paper per semester. Three Basic Courses in every semester will be the same for all students. They will have one subject specific course in their specialization. The first common Basic Course is on Law; the second is on Technical Skills and the third is on Interpersonal Skills. Each Subject specialisation course has 60-70% skill component and 40-30% knowledge component. A Student will be awarded Diploma if they exit after one year ; Advance Diploma after two years and B.A. Specialisation Degree after three years upon the successful completion of all the requirements of the course including Assignments and Examination. With completion of each year, students will acquire more complex and wider skill sets. The courses have been designed in accordance with the parameters of the Sector Skill Council under the National Skill Development Corporation keeping in view the "National Skills Qualifications Framework (NSQF)" as well as UGC requirements for B.A. Degree programme.

Duration - 4 Years

1. B.A. (Research)- Legal Counseling
2. B.A. (Research)- Legal Journalism
3. B.A. (Research)- Advocacy
4. B.A. (Research)- Legal Profession Assistants
5. B.A. (Research)- Law and Entrepreneurship



The courses offered as part of this B.A.(Law) Degree will also be open as Stand-alone “Diploma” courses in the chosen subject. Students completing that course will be issued Diploma Certificates for that Course.

For instance, a student enrolling only for the course in MS Word (after successful completion of all course requirements) will be given the Certificate of “Diploma in MS Word”.

The B.A.Degree(Law)Course will be taught in collaboration with National Institute of Social Work and Social Science (NISWASS), Bhubaneswar and Sri Sri University (SSU), Cuttack.

- 25% Seats shall be reserved horizontally for Applicants under General, ST & SC Candidates under State Domicile Reservation.
- Eligibility Criteria for Domicile Reservations: Candidates who have passed 12th class or equivalent examination from the State of Odisha and secured more than 35% in the said examination from any recognized College/ University in the State of Odisha.

NO OF SEATS FOR THE COURSE

The total number of seats for B.A. (Specialization) Programme will be 50. Maximum 10 seats are allotted for each specialisation stream. A course shall not be offered if there are less than seven students in that stream. The seats may be adjusted if vacancies are available in a given stream while another stream has been oversubscribed. Reservation of seats will be as per the Government Guidelines.

FEE STRUCTURE

- Total Fee for any stream of B.A. Specialisation per year = Rs. 35,000/-.
- It is a Non-Residential, Day scholar programme.
- Hostel facilities may be provided for some outstation Students.
- The fee for each diploma stand alone course will be Rs. 8000/- for the whole semester.

ELIGIBILITY FOR THE COURSE

- Any person with 10+2/12th / equivalent exam from any recognised school/College/Institution will be eligible for admission to the course.
- No age limit is required to take admission.

SELECTION PROCEDURE

- Candidates will be selected for admission as per the merit list to be notified based upon the 10+2 /12th / equivalent exam marks/ percentage obtained.
- The selection and allotment of stream will be done after the completion of admission purely based upon the preference of the candidate and marks/percentage obtained in 12th / equivalent exam.
- In case of tie in 10+2 /12th/ equivalent marks, the 10th class mark will be considered as a tie breaker. The candidate having more marks in 10th will be given preference.
