Ever since its inception in 2014, The National Law University Odisha – International Maritime Arbitration Moot (IMAM) is proud to hold the distinction of being the first International Maritime Arbitration Moot in India and third moot competition in the world to have maritime law as its principle subject area. The moot was started in the year 2014 with the aim of enhancing research and advocacy skills of students in the area of Maritime Law and International Commercial Arbitration. So far, the moot has witnessed six successful editions with the enthusiastic participation of teams from all across the country. The event witnesses the participation of teams from all the premier institutions of the country and what makes IMAM one of best maritime arbitration moot in India is the quality of moot propositions, the judge's profile and the calibre of the participating teams in the competition.

The subject matter of the moot is chosen with a special focus on International Commercial Arbitration in cases of maritime disputes, a subject specifically chosen not only to encourage intellectual discourse in this field of maritime law but also to bring it in harmony with the stature of the state of Odisha, being the hub of maritime activities and operations.

The previous moot propositions for this competition have been drafted by various well-known legal experts, reputed law firms and chambers. The problem for the last edition was drafted by Mr. Deven Choudhary (Shipping Claims Analyst, Legal at Scorpio Marine Management [India] Pvt. Ltd.), currently pursuing LL.M. in International Maritime Law from Swansea University.
