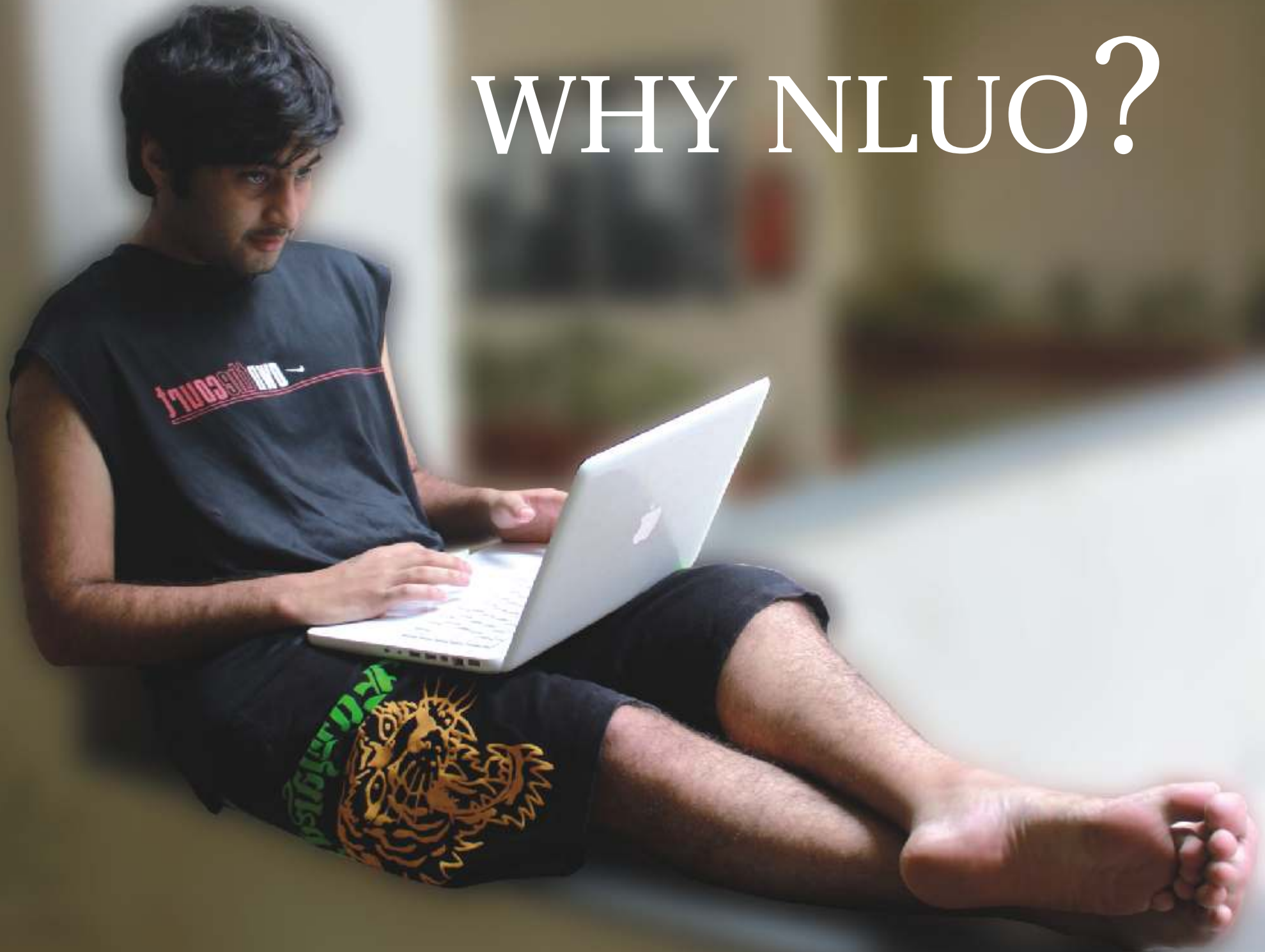
We provide best infrastructure conducive to best practices of legal education. We provide state-of-art infrastructure like fully equipped library, 24x7 wi-fi enabled

RESEARCH CENTRES

CENTRE FOR POVERTY AND JUSTICE STUDIES

In a country like India the composition and magnitude of poverty is typically wide spread and has various socio-economic ramifications. Keeping this in view, this centre aims to conduct research on the state of being poor, implications of human rights, human development, gender studies and income distribution, poverty and environment, issues of migration and labour laws, empowerment and evaluation of various plans and projects aimed at poverty alleviation. We aim to actively participate in national and international forums for framing agenda for poverty alleviation.

CENTRE FOR CLIMATE CHANGE LAW

Efforts to mitigate the implications of climatic alterations are now imperative and this centre is proposed with a view to contribute to the same. We will be the first law school in the country to take initiative in the direction of promoting exclusive legal research on climate change. The Centre will work in association with climate change scientists, harness the expertise of environmental law scholars and network with governmental, nongovernmental and academic organizations. The research orientation of the Centre include: international climate law; adaptation law and human rights and climate change.

CENTRE FOR AGRICULTURE AND FOOD LAW

This centre will provide opportunities to study how legal systems shape food systems and influence the agricultural sector. The focus of this centre will be to support an array of courses, publications, conferences, and facilitate research initiatives in agricultural law. The centre will also explore the scope of agricultural law in its convergence with food law areas. The Centre will engage students in legal issues involving the full scope of food and agriculture, including marketing and finance; biotechnology; international trade; tax planning; soil and water conservation; land use and environmental issues and food safety.

CENTRE FOR PUBLIC POLICY AND GOVERNANCE

This centre intends to provide a multidisciplinary platform for policy discourse. We intend to offer programmes that focus on equipping our students with tools for the analysis and development of public policy and cultivate the tradition of providing cutting-edge research into issues of capacity, sustainability and accountability of governments.

CENTRE FOR COMPETITION LAW AND POLICY

We are the first Law School in the country to have a specialized centre dedicated to Competition Law and Policy (CLP). It is an initiative to promote interdisciplinary research in the field of competition law and policy making, and to provide a forum where leading practitioners and academician, scholars and students, can discuss and exchange views on contemporary issues of competition law and policy.

UNDERGRADUATE STUDY PROGRAMMES



B.A.LL.B (HONS.)

B.A.LL.B (Hons.) is a multidisciplinary five year-integrated course that combines training in law with knowledge of the social sciences. In this programme, we offer five social science subjects, namely Political Science, Sociology, Economics, Legal History and English along with full range of law courses.

B.B.A.LL.B (HONS.)

B.B.A.LL.B (Hons.) is also a five year study programme which combines law with undergraduate level business administration. In this programme, we offer relevant courses from business administration and financial management along with full range of law courses.

COURSE DURATION, CREDITS, EVALUATION AND AWARD OF DEGREE

Both B.A.LL.B and B.B.A.LL.B Programmes of NLUO is organized on semester basis with at least 70 weeks of teaching/research/practical in each semester. The evaluation of students in a course shall broadly be based on both through "continuous evaluation" by the course teacher and the semester examination. A student will be eligible for the award of B.A.LL.B (Hons.)/ B.B.A.LL.B (Hons.) Degree only when he/she has successfully completed all the prescribed courses (including dissertation) with required credits and obtained a CGPA 3.0(B grade) out of 8.0. Following scale of eight using cumulative grade point average system (CGPA) has been adopted by NLUO which allocates weightage to marks obtained in each subject:

SCHOLARSHIP

To financially help its deserving and needy students, NLUO is going to offer a small number of scholarships. The university will also make every effort to announce scholarships offered by outside agencies which may be of interest to our students.

NLUO is going to come up with a policy of waiving full tuition fee of the deserving physically challenged students.



EARNING WHILE LEARNING

Earning while learning' is a student aid scheme instituted by NLUO to help students tide over financial insufficiency. Under this scheme NLUO allows students to serve in the library in lieu of remuneration to be decided by the University or work in the projects undertaken either by the university or faculty members. Owing to limited positions, students will be required to apply for these posts at the beginning of the semester. The University will select candidates on the basis of merit and need.



ACADEMIC SUPPORT PROGRAMME

To improve the performance of weak students at undergraduate level, NLUO has started its unique Academic Support Programme. In this programme, senior students and faculty

members will work as academic support counselors. They will meet regularly with the small group of students throughout the semester and provide the following services:

- Semester progress counseling and monitoring their learning in different academic disciplines
- Guidance on how to translate study habits to successfully meet the requirement of NLUO course curriculum
- Organising small tutorial classes for those students who had inadequate knowledge of English
- Assistance with any difficulties students may be experiencing in fine-tuning their time management skills
- Referrals to appropriate tutoring and other campus resources

POST-GRADUATE STUDY PROGRAMME



LL.M. PROGRAMME

(ONE YEAR)

With Post-Graduate Department in place, NLUO offers one-year LL.M Programme from the academic session of 2013-14. Through this programme, we intend to provide an ideal platform for high-calibre students to acquire expertise in specialized subject areas informed by highly experienced, research-led teaching. Our innovatively designed LL.M programme will help students develop their abilities to think critically, analyze legal arguments, articulate ideas and research efficiently.

COURSE STRUCTURE

For its one-year LL.M Programme, NLUO offers specialization in the following one area of law in the academic session of 2013-14:

CORPORATE AND COMMERCIAL LAWS

The course structure/curriculum for One-Year

LL.M. shall have the following components:

- i) Foundation/Compulsory Papers (3 papers of three credits each)
- ii) Optional/Specialization Papers (6 papers of two credits each) and will be notified in each semester.
- iii) Dissertation (3 credits)

COURSE DURATION, CREDITS, EVALUATION AND AWARD OF DEGREE

As per the UGC Regulations 2012, the one-year LL.M Programme of NLUO is organized on trimester basis. The course is of 24 credits with three mandatory courses of 3 credits each (making a total of nine credits), six optional courses of 2 credits each (making a total of 12 credits) and a dissertation of 3 credits.

The evaluation of students in a course shall broadly be based on both through "continuous evaluation" by the course teacher and the semester examination. A

student will be eligible for the award of LL.M. Degree only when he/she has successfully completed all the prescribed courses (including dissertation) with required credits and obtained a CGPA 3.0 (B grade) out of 8.0.

ATTENDANCE

No candidate shall be permitted to take the examination in any of the courses if he/she has not attended at least 75% of the classes in every course.

ELIGIBILITY AND ADMISSION

NLUO admits students to its LL.M programmes through an all India entrance examination, namely Common Law Admission Test (CLAT). The details on Eligibility criteria and Admission procedure are available at <http://www.clat.ac.in>.

PH.D. PROGRAMME

PH.D. PROGRAMME

The programme offers highly qualified and intellectually outstanding students an opportunity to pursue their research work at an advanced level in a high challenging but academically conducive environment. In pursuance of the UGC (Minimum standards and procedure for awards of M.Phil/Ph.D. degree) Regulation 2009, the Ph.D., programme of the University, is intended for those who wish to pursue research work after completing their postgraduate degrees in law and to develop higher research aptitude, and considering an academic career.

ELIGIBILITY

An applicant seeking admission to Ph.D. Degree programme must have:

1. Master's Degree in Law from any recognized University with minimum 55% marks or its equivalent in grade; or
2. Master's Degree in Law from any recognized University with 50% marks or its equivalent in grade and have had at least five years full-time teaching/judicial/professional/administrative experience in the subject; or
3. Degree in Law and a Masters Degree in Social Sciences or

Humanities, Management Studies or Sciences from

any recognized University with not less than 55% marks or its equivalent in grade; or

4. Obtained a Degree in Law and a Masters Degree in Social Sciences or Humanities, Management Studies or Sciences from any recognized University with 50% marks and have had at least five years full time teaching/judicial/professional/administrative experience in the subject;
- Or

5. Obtained a Master's Degree in Social Sciences, Sciences, Humanities or Management from any recognize University with 55% marks and have had at least two years of teaching experience; or
6. Ph.D. in any discipline; or
7. Judge of any State High Court in India or the Supreme Court of India

ADMISSION PROCEDURE

Eligible candidates may apply in any of the abovementioned categories in the prescribed form which can be downloaded from our website (www.nluo.ac.in) and sent to the Registrar with a Demand Draft of Rs. 1000/- in favour of Registrar, National Law University, Odisha payable at Cuttack. Along with the application, a candidate is required to submit the followings:

1. An outline of the scheme of research intended for the thesis;
2. A chapter-wise proposal of the work in about 2,000 words;
3. A Certificate from the institution concerned testifying length of service, wherever required;
4. An attested photocopy of LL.M., M.Phil., and M.A., M.Sc., M.Com., M.B.A. Degrees whichever is applicable, along with the marks sheet; and
5. One set of published papers, monographs, articles and books, if any.

ADMISSION TEST

1. The University will hold a RESEARCH ENTRANCE TEST (NLUO RET) in the month of August at Cuttack for admission to Ph. D. Degree for the

academic session 2014-15.

2. The test shall be of 2 hours duration, carrying 200 marks, consisting of 50 multiple choice questions and 2 descriptive answer questions.

3. Registration to the Ph.D. programme shall be based, *inter alia*, on the performance of the candidate in the entrance test and the interview conducted by the Research Council constituted for this purpose with the Chairman and two or more Faculty members of NLUO or outside experts nominated by the Vice-Chancellor.

LEGAL SERVICES CLINIC

The National Law University, Orissa has established a Legal Services Clinic. The clinic was inaugurated by Justice Dalveer Bhandari, former Judge, Supreme Court of India. The clinic uses all the methods and techniques of law for serving all those who do not have the means to hire a lawyer for consideration of their problem as well as for advice and action for appropriate relief. In this respect, the clinic will collaborate with Odisha State Legal Services Authority to facilitate its services more effectively. The clinic run by law students and teachers sends out the clear signal that none can be denied legal help on the sole ground that s/he cannot pay for it.

Legal literacy, legal training workshops for the poor and poverty jurisprudence has been used by the clinic to ensure that the poor get their

entitlements. For last three years, our students not only set up legal awareness camps in villages around Cuttack but also went to remote parts of Odisha such as Keonjhar, Kalahandi and Sambalpur in an effort to extend legal help to the needy. NLUO has also been active in ensuring that legal education is of a reputable standard throughout the State of Odisha. The clinic drafts and pleads before administrative authorities and courts the *prima facie* cases of those mentioned under Section 12 of the Legal Services Authorities Act, 1987. We also have the plan to start a help line for those in urgent need.



MOOTING AT NLUO

Moot court training and participation at NLUO is arguably one of the most significant components and as important as the academics itself since it gives the students fair chance to apply the knowledge they have gained inside and outside of the classrooms.

MOOTING AT NLUO



The Moot Society (TMS) of NLUO is managed by the students under the guidance of faculty member as Advisor, coordinates all aspects of mooting by the students. TMS organizes the annual Intra-University Moot Court Competition (IUMCC) to select students to represent NLUO in various National and International Moot Court Competitions. In addition, it organizes lectures, workshops etc. by experts to help the students in preparing for moots.



It also regularly organizes informal

discussions, workshops and practice moots for the students community. And special classes by the faculty advisor for the new comers on various aspects of mooting such as researching in library in various printed materials, using of online research databases, memorial writing including footnoting, editing etc., and preparation for oral rounds are coordinated by the TMS. Mooting in NLUO is being mentored by Mr. Rishab Sancheti, Advocate, Supreme Court of India, New Delhi and alumni of National Law University, Jodhpur.

In order to assist in preparation and to ensure access to quality research materials, NLUO provides financial assistance for participants in various moots as per the policies of the

University for the time being in force. To be eligible for financial assistance, a student must have qualified under the IUMCC of the respective year.



NLUO has organized for the second time the India South Rounds of the 18th Stetson International Environmental Law Moot Court Competition on 08-10 Nov 2013 in collaboration with Surana International Attorneys, Chennai. The university has chalked out a plan to

organize National and International Moot Court Competitions on socially relevant subjects and themes from the session 2013-2014 onwards.

OUR LIBRARY

NLUO has created a library comparable to the best elsewhere. Its resources are constantly updated to keep abreast of recent developments. In the present era of information technology, library management too is not left out from harnessing the benefits of IT. At NLUO both the academic as well as residential blocks have been provided with round the clock connectivity through leased line connection using state-of-the-art Wi-fi technology. This in turn enhances accessibility to e-resources within the University premises at all times and irrespective of the location of the users.



OBJECTIVES

- To provide the best possible library atmosphere for the University academic community;
- To provide a state-of-the-art information storage, retrieval and dissemination service;
- To assist the future lawyers and the faculty members in their teaching and learning activity by ensuring availability of high quality research resources;
- To provide the advantage of information technology to the legal fraternity;
- To cultivate the open access culture and thereby to ensure the sharing of available information from various legal and other libraries around the world.

LIBRARY RESOURCES

For easy use of resources, the library is bifurcated into two sections namely, books and journals sections. Books section contains textbooks as well as reference books including encyclopedias of different subjects. At present, there are about 15,000 volumes available in this section. There is a continuous effort to add more and more titles from different areas of study. The Journals section contains the Bare Acts, current volumes of periodicals including legal as well as non-legal refereed journals, general magazines and news papers. As regards Bare Acts, in addition to the Encyclopedia of Central Acts and Rules, around 1200 individual titles have been procured and processed. Acquisition of this remaining Acts is under progress. Currently, more than 15 news papers are subscribed by the library. It is the policy of the library to ensure that the periodicals collection is well represented across disciplines and

subject areas. In furtherance of this, the library has subscribed 100 plus periodicals including International and Comparative Law Quarterly, Harvard Law Review, Law Reports, Weekly Law Reports, All India Law Reports, Supreme Court Cases, Company Cases, Company Law Journal, SEBI and Corporate Laws, Criminal Law Journal, Divorce and Matrimonial Cases, Economics and Political Weekly, Seminar, Harvard Business Review, Management Journal of IIMs (Ahmedabad, Bangalore and Lucknow) and Linux For You, Kurushektra, Yojana etc. At the same time there has been a consistent effort on our part to ensure that the back volumes of maximum journals are procured at the earliest. The journal section contains about 6000 bound volumes and more than 1000 unbound issues of 2013. It is also our privilege to have the collection of Justice G. K. Mishra as a separate collection donated to our library.

The law graduates have to undergo internships so as to improve and sharpen their knowledge of law, adding a benefit to them. Students of NLUO intern at

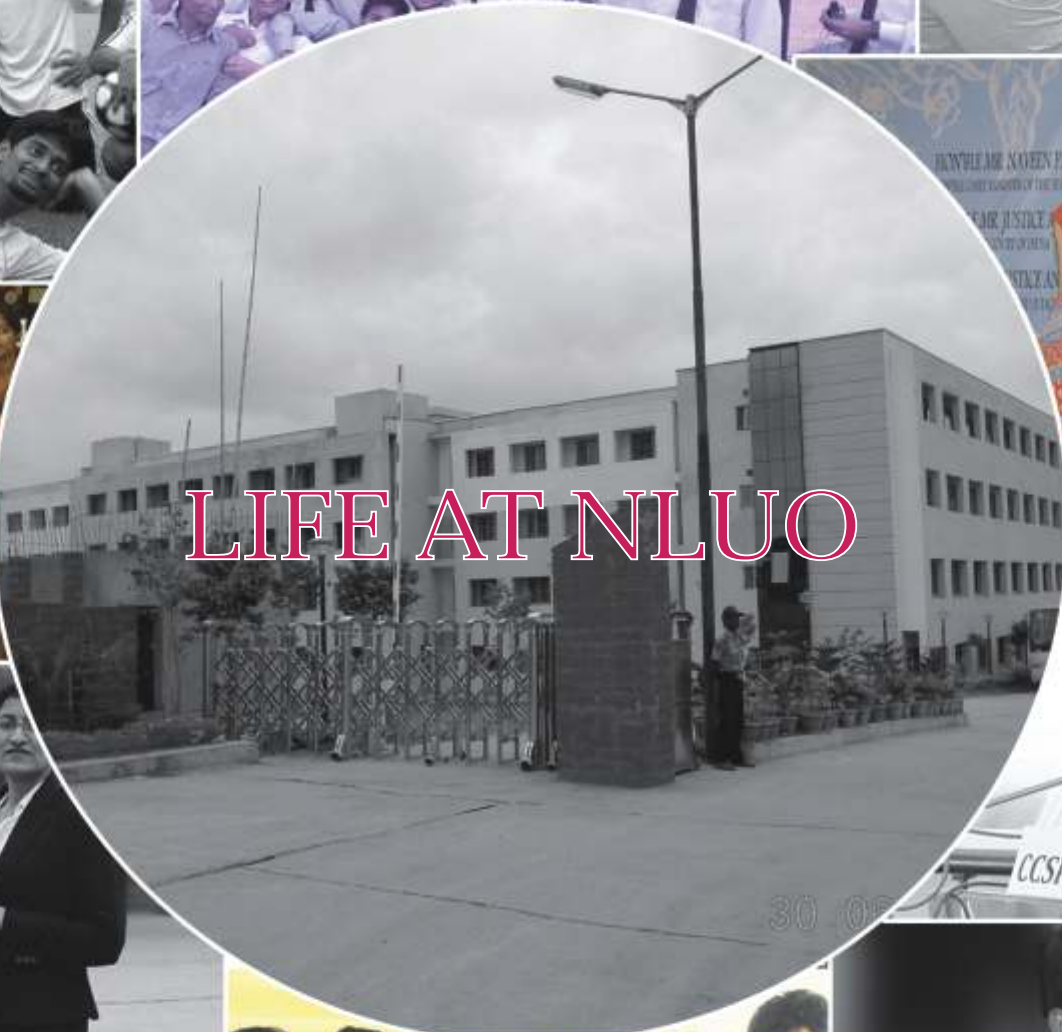

DISCIPLINARY COMMITTEE

To maintain discipline in the campus, the university has constituted three different disciplinary committees i.e. University Disciplinary Committee (UDC), Student Disciplinary Committee (SDC), Hostel Disciplinary Committee (HDC). OUR CAMPUS

Within three years of short duration, NLUO has shifted from transitory to its own Kathajodi Campus. This feat is unique in the history of national law schools in India. Located in Cuttack, the sprawling 50 acre campus will house about 700 students and staff, creating a vibrant learning environment with all the experience gained from interacting with several students, industry leaders, judges, thinkers, policy makers, philosophers. Backed by experienced faculty, excellent academic and co-curricular facilities, NLUO boasts of an educational environment with a touch of world class.

The NLUO campus is gorgeously positioned with flowing rivers on both sides presenting a picturesque view for all.

The Naraj reservoir is at the distance of a leisurely walk and the surroundings filled with natural beauty offer a soothing effect on the senses.

The campus facilities shall include air-conditioned lecture halls, language lab, gym facilities, an auditorium with seating capacity of over a thousand, an Open Air Theatre and multi-cuisine food court. The state-of-the-art library representing Odia culture and architecture in its design, will be centrally air-conditioned and can accommodate up to 2,00,000 books and over 1000 journals. Complete with Wi-Fi, rain water conservation and plantations, the NLUO campus shall leave fond memories of sustainability alongside knowledge creation. Other facilities on the campus include basketball court, football and cricket grounds.



The classrooms are spacious, comfortable, and air-conditioned. They are equipped with the latest in audio-visual equipment, such as LCD projectors and wired sound. Application of these facilities has been consciously integrated into the teaching curriculum. In most courses, viva voce examinations have been obviated by power point presentations. This not only acclimatizes students with public speaking, but also makes them familiar with tools such as Power Point and other presentation software, a valuable skill in today's professional environment. This emphasis on infrastructure also permits recourse to classroom strategies, not seen in many law schools of the country. Film screenings are frequently organised in classes, which are followed by discussion and brainstorming sessions.

The hostels have been constructed with emphasis on space and natural lighting. The rooms are spacious and enable the residents to live with comfort. Apart from a big dining room, the hostel premises shall also be equipped with television, table-tennis tables, carom boards and so on. Discipline is given considerable priority. Our security arrangements are stringent, in order to ensure the safety and security of residents and their property. Other welfare measures include round-the-clock housekeeping services, broadband Wi-Fi access, extensive first-aid facilities, and an ambulance on duty for 24 hours.



MENTORSHIP PROGRAMME

With a mission to maximize student growth and development, NLUO has introduced Mentorship Programme. We believe that mentoring is a nurturing process in which the faculty member serves as a role model, teacher, sponsor, encourager, counselor, and friend to the students with the end goal of promoting the latter's professional and personal development. This Programme is designed to help the students' transition easily into campus life, and creates events that help them build a supportive network of students, faculty and staff. We are committed to ensure the regular visit of doctors with 24 X 7 ambulance service. We have also appointed well qualified nurse to take care of the basic medical needs on campus.



ANTI-RAGGING COMMITTEE

As per UGC Regulation 2009, NLUO has formed an Anti-Ragging Committee in order to ensure "zero tolerance for ragging" in and off the university campus. Its main agenda is to prevent any sort of ragging i.e. either mental or physical that can be forced upon the fresher students. Anyone found guilty of ragging and / or abetting ragging whether actively or passively, or being a part of conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations 2009 as well as under the provisions of any penal law for the time being in force.



PULSATING WITH CUTTACK





National Law University, Odisha is located at Cuttack, the historic capital of the then Kalinga. Breathing between the Mahanadi and Kathajodi, the city is some thousand years old in stone and air. What's most interesting about Cuttack is its picturesque topography that blends beautifully with its antique buildings, making it mysteriously vibrant. Like most other places in coastal Odisha, Cuttack witnesses hot and humid weather during summer when the temperatures exceeds 40 C. Winters in Cuttack are mild and pleasant, the coolest time of the year being the month of December.

Along with twin-city Bhubaneswar, Cuttack is the hub of all academic and scholastic pursuits in Odisha. From medicine to technology, art, architecture and literature, the city offers a complete picture of flourishing academics. Law and Medicine are the most ancient professions here and Cuttack is proud to hold in its lap the oldest and biggest Medical College of Odisha, the S.C.B. Medical College along with other ancient institutions like the Ravenshaw University and Stewart School. The High Court of Odisha is also located here. Life smiles with colour here as each season fills the city with a different flavour. A summer sunset in Cuttack is particularly enchanting with shades of saffron gliding through the Mahanadi like dreams on wings of fantasy. At night, the sand, sky and water are all covered in a blanket of blue and one can see the Jobra Bridge lighted up in a straight line for

several kilometers. From a distance, it looks like the bejewelled gateway of an elf-land. The Bridge is full of road-side vendors selling seasonal fruits, nuts, fresh vegetables and salted fish.

Staying at Cuttack gives one the benefit of proximity to popular tourist destinations like Puri, Pipili, Konark, Bhitarkanika, Bhattarika, Dhauli, Udaygiri, Khandagiri and of course, Bhubaneswar. As the City of Temples, Bhubaneswar is home to a multitude of ancient architectural marvels like the Lingaraj, Kedargauri and Rajarani Temples. Cuttack owes its rich heritage to the several religious communities residing here. Hindus, Muslims and Christians dominate the demographic composition of the city and this is also why Cuttack is full of festivities all round the year. Celebrations are at their peak in October during the Durga Puja which happens to be one of the most important festivals here.

The chief attractions of Durga Puja in Cuttack are the lavish silver pandals in the city with silver filigree work carved throughout their body like fine embroidery on silk. Apart from Durga Puja, Cuttack is drowned in festivities also during Bali Jatra which happens to be the biggest fair of the region.



While at Cuttack, one must try the delicious Thumka Pooris which are unique to the Bali Jatra ground and are abundantly available only during the fair. Apart from a kaleidoscopic cultural ambience, Cuttack also offers ample scope to indulge in all modern means of entertainment as the city has many huge malls, shopping complexes, restaurants and hotels. If one's idea of a perfect evening is to hit the gym or indulge in sports and outdoor activities, Cuttack has many options to provide. The city has several modern gymnasia and the Barabati Stadium and Jawaharlal Nehru Indoor Stadium are just right for any kind of sporting activity. Facilities for river cruise accompanied by contemporary cuisine and musical nights are also available for those with subtle tastes.



In terms of cuisine, Cuttack offers a platter of spicy and sweet delicacies. Street food is sinfully tempting here and Cuttack also has several restaurants and hotels offering varieties of Indian and other cuisines for every budget. Markets brim with richly dyed cotton and silk fabrics in the Sambalpuri as well as the Sonepuri and Maniabandha patterns. Silver jewellery in the pattern of filigree, wooden, jute and coir handicrafts, appliqué work and papiere-mache from Pipili and stone and shell crafts from Puri are other attractions of the city market.

Most importantly, travel is easy here as Cuttack is well-connected by rail, road and air. The nearest airport is the Biju Patnaik Airport at Bhubaneswar. All in all, Cuttack is ideally located and designed for academic pursuits with ample opportunities for a fun-filled educational experience.

Vice-Chancellor, NLUO

With more than 25 years of teaching experience, Prof. V. Nagaraj has been recognized as one of the leading scholars on the labour law and alternate dispute resolution in the country. Currently, he is serving as Vice-Chancellor of National Law University, Odisha from March 2013. Under his leadership, NLUO is advancing at an accelerated pace in virtually all areas, including curricular innovations, student services, faculty and staff development, fund raising, diversity, academic support, reputation with legal education and the profession, and campus enhancement and expansion.

Considered a scholar-administrator, Prof. Nagaraj held successive appointments as a Lecturer in Law at Havanur College of Law, Bangalore (1989-92); Assistant Professor of Law (1992) and Associate Professor of Law (1997) at NLSIU, Bangalore; and as Additional Professor of Law (2000) and Professor of Law (2006) at NLSIU, Bangalore. He has successfully guided four Ph.D. and two M.Phil students.

Additionally, he was the Coordinator of Distance Education Programme; Academic Coordinator of Diploma in Medical Law and Ethics; Chairperson of Alternate Dispute Resolution (ADR) Chair and Executive Faculty for IBA-CLE Chair on Continuing Legal Education; Coordinator of Legal Services Clinic; Member Secretary of Governing Bodies at NLSIU. He also served NLSIU as Chairman of Under-Graduate Council (1999-2001; 2006-07) and Chairman of Post Graduate Council (2005-2006). Prof. Nagaraj developed the clinical programmes of NLSIU and the same has been substantially adopted by other law schools in India. He is the Consultant for ADB on legal education and judicial reforms. He is also associated with L& T training Centre, Mumbai for coordinating the Certification Programme particularly in Corporate Law and Contract Law. Prof. Rita Ray

Adjunct Professor of Sociology

Rita Ray has an experience of thirty-five years in academics and consulting. Her academic profile includes teaching as a full-time faculty of Sociology at Utkal University, India since 1975. Born on 31st March 1951, she is currently the senior-most female Professor, in service, in the state today. She was also the Vice chancellor (in-charge) of Utkal University for a brief, but intensely challenging, period. In this period, she provided the critical impetus needed by the institution to resurge and progress. Her contributions to the University have also continued in the capacities of Chairman (P.G. Council), Warden (P.G. Hostels) etc. In the aforementioned roles, she has especially excelled in bringing the students and management together in times of crises and resolving conflicts between the two, failing which the prestige, order, repute and progress of the institution would have been severely, possibly irreparably, compromised. One recent example of this might be her successful campaign in turning the hostels free from 'non-student' boarders. This had been, possibly, the longest unresolved issue amongst the students and management alike and the failure of which had led to severe logistical and law-and-order problems. She has been a Professor (Plan) from 1994 onwards and has lectured at many prestigious universities in India and abroad. She has been the Head of the Department (Sociology) for multiple terms and has implemented far-reaching academic and administrative contributions to the department. She has introduced numerous courses and electives in the department: A special mention, here, should possibly be made of her pioneering role in successfully introducing and popularizing Gender studies in the University, as well as in the State. She has also been a part of numerous accreditation teams and interview boards of the University Grants Commission (UGC), Union Public Services Examinations (UPSC), National Assessment and Accreditation Council (NAAC) etc. Prof. Ray has guided and awarded close to 20 Ph. D theses, mostly pertaining to issues of Displacement, Rehabilitation and Gender, and has published

extensively in national and international journals.. She has two books underway, one called 'Beyond Resettlement and Rehabilitation' with Prof. L.H. 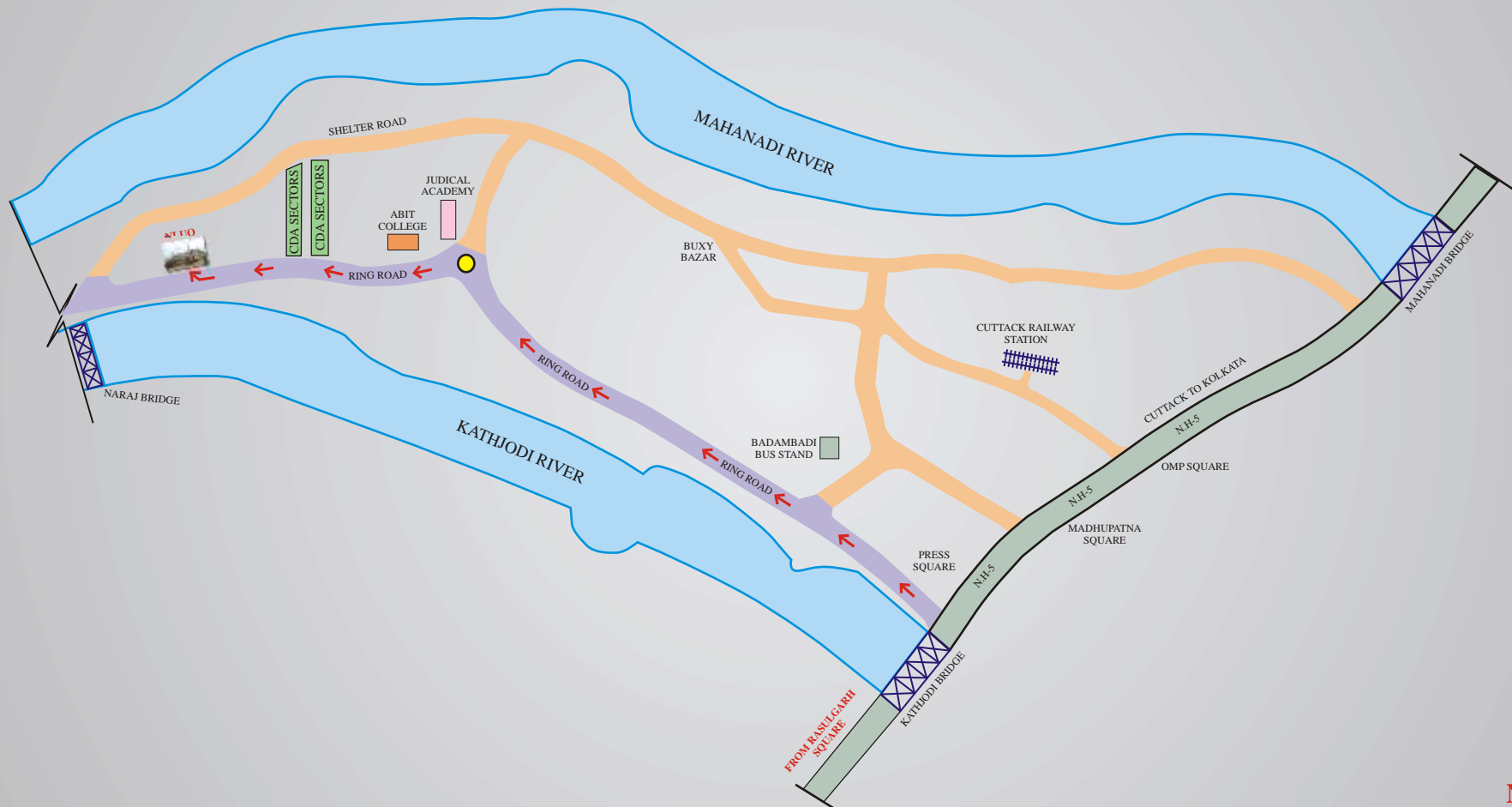
