- Indian Penal Code, 1860 (IPC) Now Bhartiya Nyaya Sanhita, 2023 (BNS
- Information Technology Act, 2000 as amended from time to time and Rules framed thereunder.
- Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 and its amendments.
- 4. Sexual Harassment of Women at Workplace (Prevention Prohibition and Redressal) Act, 2013 its amendments and rules framed thereunder.
- 5. Indecent Representation of Women (Prohibition) Act, 1986.



### Scope of Consultation

Identifying inadequacies in the present legal framework and suggesting remedial measures to make the law robust to cover advanced crimes due to evolving technology.

Analyzing the need for more gender specific provisions on cybercrimes against women as it has been experienced that in many situations, such as morphing, email spoofing and trolling, BNS provisions are applied by extrapolation and interpretation for the want of more specific provisions of law.

Devising rules/ SOPs for cybercrime reporting by women and identifying inconsistencies or scope for improvement in the existing reporting system for victims of gender based cybercrimes. Suggesting viable amendments in existing Laws with the justification covering their expected impact on Indian society.
