### **About the Course**

With the rapid growth of technology, cybercrime has emerged as a significant global challenge, encompassing a broad spectrum of criminal activities carried out using digital platforms. These include, but are not limited to, hacking, identity theft, phishing, cyberstalking, and cyberterrorism. As these crimes become increasingly sophisticated, the need for effective mechanisms to investigate, analyze, and present digital evidence has never been more critical.

This is where the discipline of cyber forensics steps in, offering a structured approach to uncover and preserve digital evidence, ensuring it is admissible in courts of law.

The course, "Exploring Cyber Forensics: Insights from the Bharatiya Sakshya Adhiniyam, 2023", is specifically designed to address these pressing issues. It offers participants a comprehensive understanding of the intersection between cybercrime and the legal processes governing the collection and presentation of electronic evidence under the Bharatiya Sakshya Adhiniyam, 2023 (earlier, Indian Evidence Act, 1872).

The course aims to bridge the gap between legal professionals, law enforcement, and forensic experts by providing a clear framework for handling digital evidence in the Indian legal context. This single-credit course will be delivered virtually, offering a flexible learning environment while maintaining a focus on interactive learning through case studies, real-life scenarios, and expert insights.

## **Teaching Methods and Tools**

Teaching tools include PowerPoint presentations and case studies to reinforce theoretical learning with practical examples.

The course will utilize various interactive teaching methods to enhance learning:

- Brainstorming and Experience Sharing: Engaging students in discussions and knowledge exchange.
- Lecturing: Structured presentations on key concepts.
- Evaluation Test: A formal examination at the end of the course.

### **Modules to be Covered**

01	Introduction to Cyber Crime and Cyber Forensics  Basics of cybercrime, types of cybercrimes, and an introduction to cyber forensics.	2hrs
02	Electronic and Digital Evidence under the Bharatiya Sakshya Adhiniyam Legal provisions for electronic evidence in India.	4hrs
03	Cyber Crime Investigation and Digital Evidence Investigation procedures and handling of digital evidence.	4hrs
04	Advanced Topics in Cyber Forensics  Social media forensics, deepfake forensics, and cryptocurrency-related investigations.	3hrs
05	Comparative Analysis of Cyber Forensics and Electronic Evidence  Global legal frameworks and best practices in cyber forensics.	4hrs
