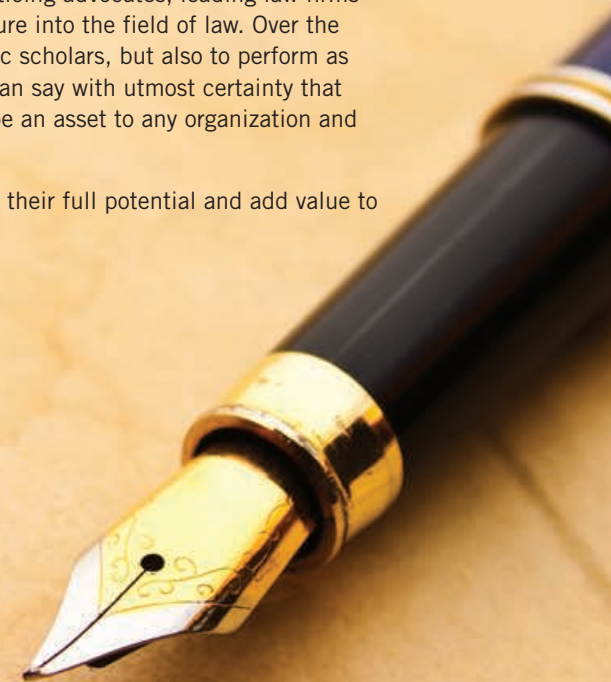

The class is a healthy mix of students hailing from various parts of India, which adds value to the learning experience that

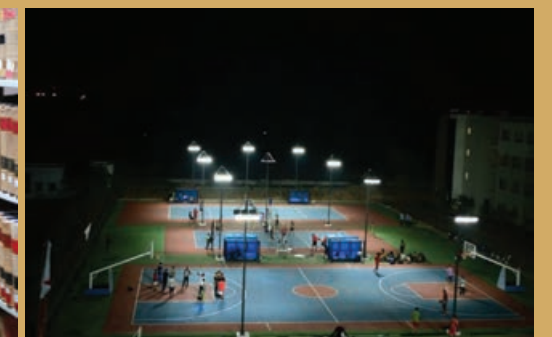

# Mooting Culture

The Moot Society (TMS) of NLUO is managed by the students under the guidance of a faculty advisor. It enjoys the mandate to coordinate all aspects of the University's involvement with Mooting. TMS has taken huge strides in providing impetus for the development of mooting culture in the University by organization of intra-college and inter college Moot Court Competitions.

International Maritime Arbitration Moot (IMAM), the flagship moot court competition of the University has earned the distinction of being a premier Moot Court Competition across the nation. In 2018, TMS organized the 5th edition of IMAM which saw the participation of 24 teams from colleges across the nation.

In addition, the Intra-University Moot Court Competition (IUMCC) is organized

every year by the TMS for the purposes of inculcating a culture of mooting among students. NLUO has been able to achieve remarkably high level of consistency in its moot court performances. This has been possible only through the hard work of students, TMS and NLUO's policy of extending financial assistance to students for participating in national and international moot court competitions.

The Legal Aid Society of National Law University Odisha is a student run committee of the University and was constituted in 2012 with constant support and guidance of its faculty advisor Asst. Prof. Suman Dash Bhattamishra. The members and volunteers of the Society are a group of enthusiastic students who have constantly been involved in various activities to keep the spirit of legal aid alive.

The Society carries out its functions with an aim to provide access to justice to the disadvantaged and marginalized sections of the population, primarily by spreading legal awareness and legal education in educational institutions and under-privileged communities. Since its inception, the Society has conducted numerous Legal Literacy Programmes in remote areas of Odisha, predominantly in schools, colleges, orphanages, mental asylums, prisons, brick kilns and old age homes, in addition to conducting several legal surveys in order to identify issues faced by the target groups and formulating solutions to solve the same.

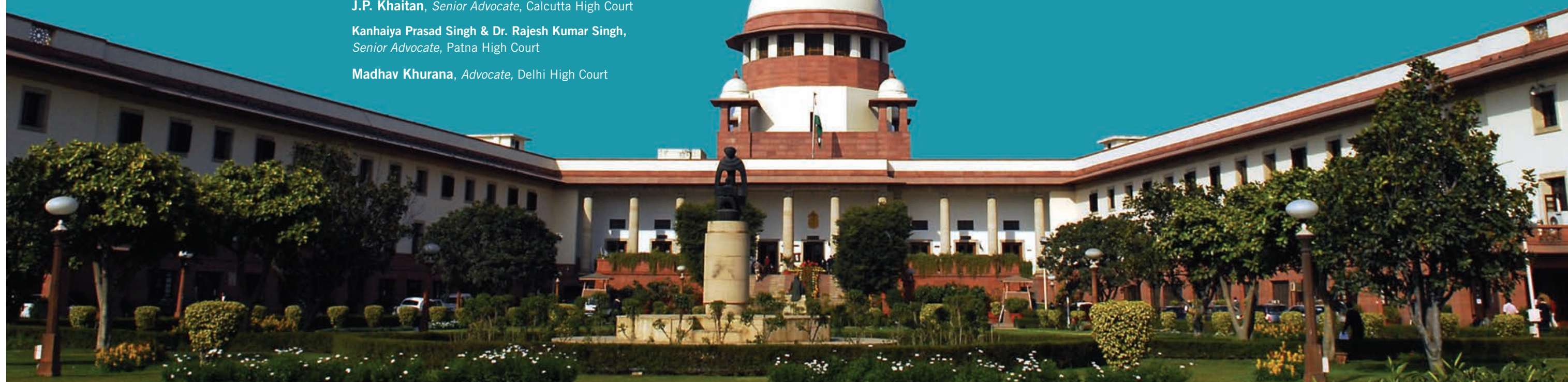
