

THE CENTRE FOR MARITIME LAW (CML)

CML, NLUO was established with an aim to build a Centre of excellence in the field of maritime law in India. The Centre is constantly and eagerly working to expand the horizons of research and discussion on Maritime Law by focusing on Indian Statutes, case laws, international treaties and conventions. The Centre's primary objective is to crystallize the current maritime jurisprudence in India. This year the Centre has successfully organized its 1st International Conference on Maritime Law in collaboration with Paradip Port and HP Law Mumbai. The Centre has also published a book.



THE CENTRE FOR BANKING AND INSURANCE LAWS (CBIL)

The CBIL is a specialized Centre dedicated for facilitating higher learning, research and allied activities in the said domain of law. Further, it acts as a facilitator for intellectual debates on the said domain of law by regularly arranging for Symposiums, Seminars and Workshops on banking and financial laws. The Centre aims to conduct various events pertaining to the such areas of laws which will inculcate better understanding to nuances of banking laws and insurance laws.



THE CENTRE FOR CHILD RIGHTS (CCR)

CCR runs in collaboration with UNICEF which gives short term & long term goals to the Centre and facilitates the working of the Centre in all its dimensions. The Centre has a wide outreach working at regional, national and international level. The Centre holds sessions, seminars, lectures and further conducts quality research to come up with resolutions for various organizations. In 2019, the Centre organized the Judicial Colloquium on Juvenile Justice with Judges of Supreme Court and the High Court, Directors of Judicial Academy, National Law Schools, Advocates, Child Rights Activists and Magistrates of JJBs in Odisha.



THE CENTRE FOR CORPORATE LAW

NLUO is one of the first National Law Universities to set up a research centre dedicated to corporate law and policy. The Centre for Corporate Law is an initiative to promote interdisciplinary research in corporate law, and related fields like competition law and policy making, conflict management and banking and insurance laws. The Centre offers consultancy and training programmes for judges, lawyers, corporate executives, students and enforcement officials.



THE CENTRE FOR CONSUMER LAW (CCL)

CCL-NLUO is dedicated to one of the most contentious areas of law - consumer law. With the capitalistic tendencies of the community on rise, it becomes essential to protect the rights of the consumers. The Centre for Consumer Law is one of the most active Centres in the University, and partners with the state government and firms across the nation to identify the research gaps in this domain, and conducts thorough primary and secondary research to propose concrete resolutions for numerous issues. In 2019, the Centre successfully conducted its 1st Intra-University Essay Writing Competition and organized a Two-Day Certificate Course on 'Consumer Justice in the Era of Globalization' in collaboration with the Chair on Consumer Law and Practice, NLSIU, Bengaluru.



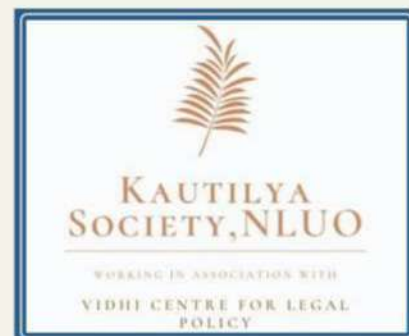
THE LEGAL AID SOCIETY

Established in 2012, the Legal Aid Society of National Law University Odisha is a student-run committee of the University. The Society carries out its functions with an objective to provide access to justice to the disadvantaged and marginalized sections of the population, primarily by spreading legal awareness and legal education in educational institutions and under-privileged communities. Since its inception, the Society has conducted numerous Legal Literacy Programs in remote areas of Odisha and has conducted various webinars for the benefit of students as well.



KAUTILYA SOCIETY

The Kautilya Society, NLUO Chapter, established in collaboration with Vidhi Centre for Legal Policy, is a policy engagement society which endeavours to increase student participation in the legislative process and promote public policy as a thriving career path. The Society aims at providing a forum to law students for participating in and contributing to public policy discourse, and in consequence, enabling them to gain real-world insight into legislative analysis. The Society conducts primary field research to assist the Nyaaya- an initiative of Vidhi- to make justice accessible to all and identifies the gaps in law and governance. It hosts events concerning legislative drafting talks and discussions.



IDIA: ODISHA CHAPTER

NLUO proudly houses the Odisha Chapter of IDIA. Presently, the University is home to two scholars and one trainee and has been the avenue to legal education for multiple other scholars in past. It provides scholarship support when they reach the institution along with the additional support and resources. The team regularly undertakes sensitization sessions, legal aid drives, literacy programs and fundraising activities. The Batch of 2022 has helped in training scholars, the waiver of various fees for such scholars and has guided the Chapter through the support of Team Leader and Deputy Team Leader.



ALUMNI RELATIONS SOCIETY

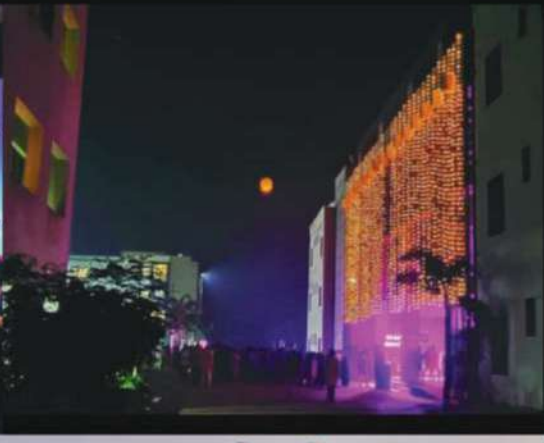
