

## **Notification for Admission to B.A. LL.B. (Hons.) / B.B.A. LL.B. (Hons.) / LL.M. Programme under NRI/NRI Sponsored/ PIO / OCI Category for the Academic Year 2025-2026**

Out of the total 120 seats of B.A.LL.B. (Hons.) and 60 seats for B.B.A.LL.B. (Hons.) Programme, 15 Seats (10 in B.A.LL.B. & 5 in B.B.A.LL.B.) are allotted to NRI/NRI sponsored / PIO / OCI candidates. Similarly in LL.M. Programme 4 seats are allotted to NRI/NRI sponsored / PIO / OCI candidates.

Candidates who wish to apply to B.A.LL.B. (Hons.) / B.B.A.LL.B. (Hons.) / LL.M. Programme for the Academic Session 2025-2026 under NRI / NRI Sponsored / PIO / OCI Categories need to apply online, send hard copy by Speed Post and soft copy (scanned copy) by email before 15.05.2025. The application fees of ₹2,000/- (Rupees Two Thousand only) must be made online using **State Bank of India Collect portal** (please refer the [procedure for payment of application fees using SBI Collect](#) for more information).

Candidates of the above mentioned categories shall fulfil other requirements regarding age and qualifications as per CLAT-2025 and NLUO eligibility Regulations.

Applications under NRI / NRI Sponsored / PIO / OCI Category shall be considered for admission in case the candidate had appeared for CLAT 2025 under NRI/NRI Sponsored / PIO / OCI Category. They shall send the filled in application form along with the copy of the Admit Card of CLAT 2025, other relevant documents and prescribed fees. They shall be admitted as per their Rank in CLAT 2025 depending upon the vacancies.

This amount of ₹ 2,000/- is non-refundable, non-adjustable and non-transferable. Once the candidate is admitted under the NRI / NRI Sponsored / PIO / OCI Category the admission will not be converted into any other category subsequently.
