
The Ministry of Jal Shakti was formed in May 2019 by merging the Ministry of Water Resources, River Development and Ganga Rejuvenation and the Ministry of Drinking Water and Sanitation. The Jal Shakti Abhiyan was launched by the Ministry of Jal Shakti in year 2019, as a campaign for water conservation and water security through a collaborative effort of various ministries of the Central and State Governments. The major focus of the campaign is on the districts and blocks that suffer water stress.

Jal Shakti team of National Law University Odisha has been constituted as per the direction of the Ministry of Human Resource Development as a part of its observation of Swachhta Pakwada. It came into action in June 2021. It is envisioned to provide safe and adequate quantity of prescribed quality water and harvesting rainwater or having its own rain gauge or rain recording system. Jal Shakti Campus also aims to completion of UN's ensuring availability of water and its sustainable management and sanitation for all by 2030 and will also ensure that educating people and making the society aware of the need for water conservation.

COURSE OVERVIEW AND OBJECTIVES

This course provides a comprehensive examination of water law, governance, and diplomacy in India, with a focus on the legal frameworks, rights, and dispute resolution mechanisms that govern water resources. Students will explore key constitutional provisions, legislation, and judicial interpretations that shape water governance in India, including the allocation of water rights and the regulation of surface and groundwater. The course also delves into interstate water conflicts, with case studies like the Cauvery River dispute, and assesses the legal instruments and institutional frameworks for resolving these conflicts.

Additionally, it offers an understanding of international water law principles, emphasizing India's transboundary water diplomacy with its neighbouring countries. By the end of the course, students will have a solid understanding of the legal and policy challenges in water governance, the evolving role of law in addressing conflicts, and India's approach to international water negotiations.



Module-I: Legal Framework Governing Water in India

Lecture 1: Constitutional Provisions and Legislative Competence in Water Governance Overview of water-related provisions in the Indian Constitution (Articles 21, 246, 262, etc.), the division of powers between the Centre and States, and key legislations like the River Boards Act, 1956

Lecture 2: Judicial Interpretation and the Role of Public Interest Litigations (PILs) in Water Law Focus on landmark judgments by Indian courts on water laws, including the role of PILs in advancing water rights and environmental protections.

Module-II: Water Rights and Allocation

Lecture 3: Evolution of Water Rights: From Riparian Rights to Modern Allocation Mechanisms
Historical development of water rights in India, comparison of riparian rights, prior appropriation, and emerging allocation frameworks.

Lecture 4: Groundwater Governance: Legal and Regulatory Challenges
Analysis of the legal complexities surrounding groundwater regulation in India, focusing on access rights, over-extraction, and the role of recent reforms.

Module-III: Interstate Water Conflicts in India

Lecture 5: Legal Framework for Resolving Interstate Water Disputes: The Inter-State Water Disputes Act Detailed study of the Inter-State Water Disputes Act, 1956, and its implications in resolving conflicts between Indian states over shared water resources.

Lecture 6: The Cauvery River Dispute: A Case Study of Federalism and Conflict Resolution Examination of one of India's most prominent interstate water conflicts, focusing on the legal battles, tribunals, and political dynamics involved.

Module-IV: International Water Law & Diplomacy

Lecture 7: Principles of International Water Law: Equitable Utilization and No-Harm Rule Introduction to key doctrines in international water law, including the principles of equitable utilization and the no-harm rule as applied to transboundary rivers

Lecture 8: India's Transboundary Water Diplomacy: Challenges and Opportunities with Neighbouring States. An exploration of India's international watersharing agreements with neighbouring countries (e.g., the Indus Waters Treaty with Pakistan, agreements with Bangladesh), and the diplomatic challenges involved.

LEARNING OUTCOME

By the end of this course, students will have a comprehensive understanding of the legal frameworks governing water in India, including constitutional provisions, statutory laws, and judicial interpretations. They will be able to critically analyze water rights, allocation mechanisms, and the complexities of interstate water conflicts, such as the Cauvery River dispute, while assessing the effectiveness of legal dispute resolution mechanisms. Additionally, students will gain insights into international water law principles and evaluate India's transboundary water agreements and diplomacy. Equipped with these legal and policy frameworks, students will be able to apply their knowledge to contemporary challenges in water governance and develop informed recommendations for improving legal mechanisms at both domestic and international levels.
