<p>ISO Surveillance Audit: The University is ISO 9001:2015 certified by Bureau of Indian Standards for providing undergraduate programmes, certificate programmes, post graduate and post graduate diploma programmes and doctoral studies related to law. The 1st ISO Surveillance Audit was conducted by the Bureau of Indian Standards on 15 th and 16th July 2024. A certificate confirming the Quality Management System of the University as per standard ISO 9001:2015 has been issued by the Bureau of Indian Standards. Academic and Administrative Audit: In accordance with the guidelines by NAAC, the University has successfully conducted Academic and Administrative Audit on 23rd April 2024. The University has taken initiatives on improvement on different qualitative aspects on the basis of suggestions and recommendations given by the members of the Academic and Administrative Audit Committee. Continuous improvement in teaching learning process: IQAC focusses on strengthening the teaching learning process by taking into account the current market requirements. The courses are updated by the faculty members on a regular basis taking into account the multi-disciplinary perspectives. The courses were revised by the faculty members and the same were presented before the experts before the commencement</p>		

of the session. The course outline presentations took place from 17-19 November 2023 and 27 May and 19 June 2024. Faculty Seminars: IQAC organised 11 faculty seminars in 2023-24 where the faculty members shared their respective research papers and ongoing research. It provide an opportunity to the faculty members to take opinion of colleagues and experts to improvise their research papers. Promotion of Research and Publication: To promote the research and publication among the faculty members, the National Law University Odisha Publication Incentive Regulations 2022. Continued Focus of strengthening Clinical Legal Education: To strengthen the Clinical Legal Education, the University has established an office of the Legal Aid Clinic on the main gate of the University. In addition to the Campus Legal Aid Clinic, the University has a Legal Aid Clinics in Dompada, Cuttack and Jankia, Khorda respectively. These Clinics are providing help to the inhabitants of nearby vicinity in reaching the services of District Legal Services Authority and State Legal Services Authority. Clinical Legal Education is an important course for the students where regular field visits are also undertaken. Strengthening the research centres: The research centers are promoted to conduct Credit courses. Several Research Centres sent the proposals to start Credit Courses. In this regard, following Single Credit and Double Credit Courses were conducted: Single Credit Courses: Online Certificate Course on Cyber Law and Cyber Security Adjudication of Housing and Land Rights Gendered Justice Negotiation and Mediation Training Contract Drafting Pharmaceutical Industry, Public Health, and Intellectual Property Rights Procedures and Practices of International Commercial Arbitration Equality Jurisprudence Legal Foundations for Technology, Innovation, and Entrepreneurship: Navigating the Digital Era Legislative Drafting Double Credit Course 'Introduction to WTO Jurisprudence (July 2024) Practical Aspects of Insolvency Laws.

<p>National Law University Odisha offers B.A.LL.B. (Hons), B.B.A.LL.B. (Hons.), Three Year LL.B., B.A. (Law), LL.M. and Ph.D. programmes. Recognising the importance of interdisciplinary approach, the study of law is combined with Sociology, Political Science, Economics, Language and Literature in UG level courses. It combines the study of law with management and finance. In addition to the subject recommended by Bar Council of India, the additional subjects are also being offered to the students. B.A.LL.B. Programme includes the social science subjects including Law and Language, Introduction to Political Science, Legal History, Law Literature and Films, Contemporary Political Discourse, Architecture of Social Life, Sociology of Social Issues & Debates, Global Politics and Governance, Microeconomics, Organizational Behaviour, Basic Principles of Accounting, Macroeconomics, Economic Development and Planning in India, Sociology of Social Transformation etc. B.B.A.LL.B. Programme also covers the social science subjects including Law and Language, Basic Principles of Accounting, Law, Literature and Films, Introduction to Political Science, Cost and Management Accounting, Corporate Accounting, Principles and Practices of Management, Organizational Behaviour, Human Resource Management, Fundamentals of Marketing Management, Business Economics, Introduction to Sociology, Strategic Management etc. B.A. (Law) Programme also focusses on interdisciplinary approach towards different courses. It has papers of Legal Counselling, Law and Entrepreneurship, Advocacy, Legal Profession Assistant and Legal Journalism etc. Three Years LL.B. Programme covers the compulsory papers notified by the Bar Council of India and additional optional papers in the emerging areas. LL.M. programme covers the compulsory papers and optional papers. Although the focus is on law subjects, the discussions take place from a global and dynamic perspective. NLUO also offers Ph.D. programme on inter- disciplinary subjects</p>	

fulfilling all the requirements prescribed by UGC including coursework, six months progress report, pre-submission presentation and open viva.

17.Academic bank of credits (ABC):

The University has adopted the ABC system for the benefit of students and their academic growth. Students have already enrolled on the ABC portal and proper procedure thereof has been laid out on the university website. The University implemented Choice based credit system (CBCS) in January 2023.

18.Skill development:

National Law University Odisha is committed to provide practical aspects of subjects offered to UG and PG level programmes. In this regard several courses are being offered as compulsory papers and in addition to which the technical papers are offered as optional papers to provide the practical aspects of the emerging areas. Students are trained for participation in Moot Court Competition which helps in developing Advocacy Skills. In 2023-24, 10 (ten) single credit courses and 2 (two) double credit courses were offered by the research centres to develop the technical and professional skills of the students. The details are as follows: Single Credit Courses: 1. Online Certificate Course on Cyber Law and Cyber Security 2. Adjudication of Housing and Land Rights 3. Gendered Justice 4. Negotiation and Mediation Training 5. Contract Drafting 6. Pharmaceutical Industry, Public Health, and Intellectual Property Rights Procedures and 7. Practices of International Commercial Arbitration 8. Equality Jurisprudence 9. Legal Foundations for Technology, Innovation, and Entrepreneurship: Navigating the Digital Era Equality Jurisprudence 10. Legislative Drafting Double Credit Course 1. 'Introduction to WTO Jurisprudence (July 2024) 2. Practical Aspects of Insolvency Laws. The students are required to undertake the clinical courses to provide a practical exposure of problems prevailing in the society. It is destined to improve communication skills and leadership skills. For LLM programme, a course on research methodology is a compulsory paper which develop the technical skill and provides the knowledge about research, ethics and techniques to the students. Additionally several activities like moot court competitions, sports fest, cultural fest, debates, essay writing competition, ADR competition, etc. are organized on a regular basis to impart and improve the organising and leadership skill. The University has also incorporated Section 8 Company under the Companies Act, 2013 to promote the incubations and entrepreneurship in the University. It will help in developing the entrepreneurial

skills of the Student. The University has organised 14 outreach and extensions activities under Project KUTUMB by the University. The NSS Bureau of NLUO conducted 8 outreach programmes on different areas of public importance including voter awareness, swachata hi seva etc. Legal Services Committee of NLUO conducted 8 extension activities and other centres and committees including Pro Bono, Centre for Consumer Law, Sports Committee, Centre for Mediation and Negotiation, Centre for Child Rights also conducted outreach and extension programmes. All the programmes are organised by student committees and research centres under the guidance of faculty advisors and directors of research centre which provide first hand experience to the students. It also helps in understanding the practical aspects and develop the organising and managing skills of the students.

19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The University integrates the knowledge of Indian culture by providing the practical trainings and field visits to the students. Several courses also integrate Indian values and culture. To mention few, the Course on Public health law covers the importance of knowledge of Indian vedas in the field of health and safety. The course on corporate law covers the aspects of corporate governance, wherein the business ethics and Indian culture and values are also discussed. The course of socio-economic offences throws light on the social and historical aspect of Indian society and the reasons or justifications for providing protection for socio economic offences. The paper on traditional knowledge and IPR also discusses Indian traditional knowledge and the measures existing in ancient times to safeguard the traditional knowledge. The courses on Environmental Law, Legal History, Human Rights, Jurisprudence, Literature and Films, Sociology, Introduction to Political Science, Tribal Identity and Forest Rights in India covers the aspects of various religious texts like shastras, upanishads etc . In addition to this, the faculty members integrate the knowledge of Indian culture in their respective courses. NLUO has also integrated the local art, crafts, and cultural aspects in the courses of Intellectual Property Rights, Criminal Law and Personal Laws. The research centres also play an important role in providing the knowledge to the members and general masses about different areas. Further the students are encouraged to learn these traditional skills of Yoga and meditation. Film screenings on various issues are screened and discussed. The library of the University also provides newspapers in different languages including English, Hindi and Odia.

20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

The University focuses on the outcome based education and the same is taken into account while developing the course outlines of courses. The courses explicitly provide the objectives and expected outcomes which are based on the University's mission and vision. As a professional Law University, NLUO provides focussed learning to cater the needs of the students. The classroom teaching helps the students in undertaking the internships with the law firms, chambers of judicial officers, advocates, NGOs, think tanks and other national and international bodies. The outcome of the courses are designed taking into account the professional and local needs. 21.Distance education/online education:

The University is continuously working to enhance teaching-learning experience. In this regard, the online education plays an important role. To promote online education, the University organises several webinars on a regular basis. In addition to this, the faculty members use Google Classroom for submission of projects and circulation of reading material. Several credit courses were conducted in Hybrid and online mode by the research centres of NLUO. A Certificate course on Climate Change - Law, Justice and The Global South was organized by the Centre for Research and Management of Natural Resources (CRAMON), National Law University Odisha, in association with Law, Environment and Development Centre (LEDC), SOAS University of London. Further NLUO jointly with the Cyber Law University organised "Online Certificate Course on Cyber Law and Cyber Security." The course has an aim to disseminate knowledge regarding the constantly evolving trends impacting cyberspace and connected paradigms. Online Single Credit course on 'Adjudication of Housing and Land Rights' was conducted by the Centre for Research and Management of Natural Resources in collaboration with Housing and Land Rights Network. National Law University Odisha's Center for International Trade Law offered a 2 credit course on 'Introduction to WTO Jurisprudence'. The course not only delves into the mysteries of functioning of the WTO but also throws light on the contemporary issues plaguing the international organization. Double Credit course on Practical Aspects of Insolvency Laws was conducted by Centre for Banking and Insurance in collaboration with Insolvency and Bankruptcy Board of India. A Single Credit Course on the theme of 'Equality Jurisprudence' was conducted by the Constitutional Law Society between March 8 & March 10, 2024. All these initiatives were undertaken to promote the distance education and online learning.

Among the Programme Outcomes of the 5-year B.A.LL.B. & B.B.A. LL.B. and LL.M. programmes, the University emphasises on an in-depth understanding of the laws, rules and regulations at the local, regional, national and international level. This is ensured at the course design presentations before the beginning of every semester and before the course, designs are circulated to the students. Clinical courses offered at the university such as legal aid, and ADR together with its outreach programs keep the students connected with the local and regional issues. University offers B.A. Law course which largely caters to requirements and skill development for local students. Special subjects offered like

- Public Health Law
- Access to Medicine and Patents
- Child Rights
- Disaster Management Law
- Water Law
- Election Law, etc.

in addition to compulsory courses like Constitutional Law and Criminal Laws keep the students abreast with the national political, economic and social issues. The University also has extensive courses that are relevant to global developments. Some of the courses that may be highlighted here are:

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

Professional Ethics and Human Values:

1. Compulsory course on Professional Ethics and a clinical course on Trial and Appellate Advocacy aims at building professional ethics in the students. Course on 'Alternate Dispute Resolution' instils the human value of amicable problem-solving.

2. Clinical course on 'Legal Aid and Drafting, Pleading and Conveyancing includes field visits by students to identify various societal problems and explore legal solutions.

Gender:

1. 'Gender and Law' is offered to PG students.

2. Discussions on gender and inclusiveness are situated as a part of some of the BCI mandated courses at the undergraduate level like Sociology, Human Rights, Constitutional Law, Personal Laws, Labour Laws etc.

3. Elective course on 'Public Health Law' incorporates issues like the reproductive health of women.

4. Clinical Legal Education (CLE) students are encouraged to identify gender issues.

Environment and Sustainability

1. Compulsory course on Environmental Law is offered to the students of undergraduate course as per the mandate of BCI.

2. Faculty is encouraged to incorporate sustainability discussions in their outline. Example of such courses are integrated issues of sustainability are water law, public health law, biotechnology and law, international trade law, international investment law, law and justice in a globalised world, energy law, and infrastructure law.

3. Discussions on sustainability are included in courses like Microeconomics, Macroeconomics, and Strategic Management.

The Research and Internationalization Committee oversees all research work including Ph.D. at the university. The Committee strives to create a conducive environment for enhanced research productivity by incentivizing research, encouraging intra and inter-disciplinary collaborations, creating policies to provide support to young scholars and professionals for not just conducting but also publishing research, conducting thorough coursework for Ph.D. scholars and monitoring research activities in the university, in general. The university has 21 Research Centres that encourage collaborative research work among faculty members, students and professionals from across the world from various fields of work. Publications of NLUO include four journals and various other scholarly works like edited books and newsletters published by various research centres. The RIC maintains files and records of all ongoing and completed research work done by faculty members including a list of faculty publications. A major step taken by RIC is to provide financial incentive to faculty members for publications in UGC CARE and SCOPUS -indexed journals. Other than that, there are seed-funding and travel grant policies in place to provide benefits to provide financial support to faculty members for initiation and presentation of research work.

It operates 21 specialized research centres focusing on niche legal areas like Public Health Law and Maritime Law. These centres drive research by conducting seminars, guest lectures, and research projects while offering credit and certificate courses.

Collaboration is a key pillar of the University's research culture. It has signed MoUs with renowned institutions, including SOAS University of London and Cyber Law University, enabling joint course development. Additionally, partnerships with non-academic organizations promote research in specialized legal fields, strengthening industry-academia linkages.

To enhance scholarly contributions, the University publishes two ISSN-registered journals and research centre-specific periodicals and newsletters.

Beyond research, the University emphasizes community engagement through initiatives like the Legal Aid Society, Pro Bono Club, UBA Society, NSS Units, and Mediation Clinics. These platforms provide hands-on learning and social impact opportunities. The KUTUMB initiative further supports community outreach.

Promoting entrepreneurship and innovation, the University has established the NLUO Incubators Forum under the Institute Innovation Council and offers a compulsory Law and Entrepreneurship course. An MoU with Start-up Odisha bolsters the state's entrepreneurial ecosystem.

Through these initiatives, the University continues to expand the frontiers of legal research, education, and community engagement.

NSS Bureau: The NSS Bureau aims at general welfare of local communities and makes interventions like health camps, cleanliness drives, plantation drives etc. Project Kutumb: This project focuses on the welfare of children in three adopted villages and aims to develop indicators to assess child-friendliness of villages. The students under this project conduct door to door survey and regular meetings with stakeholders in the villages to understand the issues and concerns from a child welfare perspective. Unnat Bharat Abhiyan (UBA): The UBA cell of the University has adopted five adjoining villages and aims to enrich

- **Rules and Regulations:** The University has adequate infrastructure for effective functioning of all its academic programmes like dedicated academic block, separate moot court hall, library, reading rooms etc. There is a policy for allocation of classrooms for use for various academic activities. Generally, there are Proctor Rules, 2024 governing use and access of resources and conduct of students within the University campus and Hostel Rules, 2024 regarding maintenance and use of facilities within the hostels. There is a Standard Operating Procedure (SOP) regarding access to and maintenance of library.
- **Orientation of students and appointment of Committees:** There is a provision for an Orientation Programme for the newly admitted students before the commencement of academic session to orient them about the academic and support facilities available in the campus. Maintenance of sports infrastructure facilities is taken care by a civil engineer under the supervision of the Registrar. Besides, the Campus Development Committee works towards proper use and maintenance of all academic and support facilities. Further there are administrative committees like Vendor Supervision Committee (Committee for supervising Landscaping services, housekeeping services, pest control services, water cooler services), Purchase Committee, Tender Committee etc. constituted to supervise maintenance and utilization of

various infrastructure services.

NLUO has an empowering and transformational leadership. The NLUO Act, 2008 has identified composition of the University in section 3 as Chancellor, Vice-Chancellor, General Council, Executive Council, Academic Council and the Registrar. Section 10 has identified the authorities of the University to include Finance Committee along with those mentioned earlier. At NLUO the leadership while maintaining accountability has ensured existence of trickle down management system allowing for complete decentralisation. The organogram (as attached) indicates the structural decentralisation as followed by the institution. All decisions at NLUO are taken in a participative and consultative manner where inputs from faculties are sought either through emails or during the periodic Faculty Meetings whose agenda is floated beforehand. NLUO has a very dynamic strategic plan which allows for mid-course correction as well as amendments and introduction of newer initiatives in furtherance of the larger University Plans.

NLUO's institutional strategic plan is directed at Student Education, Growth and Development. For Education a strong curriculum for students with periodic reviews from external experts for every term is prepared and is coordinated by the Academic Coordination committee.

The office of registrar is also ensuring continuous recruitment of new faculties for improving the student teacher ratio.

The Research and Internationalization Committee oversees all research work including Ph.D. at the university. The Committee strives to create a conducive environment for enhanced research productivity by incentivizing research, encouraging intra and inter-disciplinary collaborations, creating policies to provide support to young scholars and professionals for not just conducting but also publishing research, conducting thorough coursework for Ph.D. scholars and monitoring research activities in the university, in general. The university has 21 Research Centres that encourage collaborative research work among faculty members, students and professionals from across the world from various fields of work. Publications of NLUO include four journals and various other scholarly works like edited books and newsletters published by various research centres. The RIC maintains files and records of all ongoing and completed research work done by faculty members including a list of faculty publications. A major step taken by RIC is to provide financial incentive to faculty members for publications in UGC CARE and SCOPUS -indexed journals. Other than that, there are seed-funding and travel grant policies in place to provide benefits to provide financial support to faculty members for initiation and presentation of research work.

The University fosters a dynamic research and knowledge-

creation ecosystem through various initiatives. It operates 21 specialized research centres focusing on niche legal areas like Public Health Law and Maritime Law. These centres drive research by conducting seminars, guest lectures, and research projects while offering credit and certificate courses.

Collaboration is a key pillar of the University's research culture. It has signed MoUs with renowned institutions, including SOAS University of London and Cyber Law University, enabling joint course development. Additionally, partnerships with non-academic organizations promote research in specialized legal fields, strengthening industry-academia linkages.

To enhance scholarly contributions, the University publishes two ISSN-registered journals and research centre-specific periodicals and newsletters.

Beyond research, the University emphasizes community engagement through initiatives like the Legal Aid Society, Pro Bono Club, UBA Society, NSS Units, and Mediation Clinics. These platforms provide hands-on learning and social impact opportunities. The KUTUMB initiative further supports community outreach.

Promoting entrepreneurship and innovation, the University has established the NLUO Incubators Forum under the Institute Innovation Council and offers a compulsory Law and Entrepreneurship course. An MoU with Start-up Odisha bolsters the state's entrepreneurial ecosystem.

Through these initiatives, the University continues to expand the frontiers of legal research, education, and community engagement.

Extension activities in the neighbourhood community are conducted through the following student bodies. The detailed activities are outlined in the Annual Reports.

Legal Services Committee: The LSC aims at promoting access to justice through various extension and outreach activities such as legal literacy programmes in schools, child care institutions, orphanages etc. The Legal Services Committee also extends para-legal services (like filing complaints with Human Rights Commission, obtaining ration card, disability pension etc.) to peripheral communities through its legal aid clinics.

NSS Bureau: The NSS Bureau aims at general welfare of local communities and makes interventions like health camps, cleanliness drives, plantation drives etc.

Project Kutumb: This project focuses on the welfare of children in three adopted villages and aims to develop indicators to assess child-friendliness of villages. The students under this project conduct door to door survey and regular meetings with stakeholders in the villages to understand the issues and concerns from a child welfare perspective.

Unnat Bharat Abhiyan (UBA): The UBA cell of the University has adopted five adjoining villages and aims to enrich the status of living through structured community outreach programmes like medical camp, career counselling and guidance to students of the village, conducting Gram Sabha etc.

Web-Based Interface: KOHA operates via a web-based interface, which means it can be accessed from any device with an internet connection, whether on-campus or remotely.

OPAC (Online Public Access Catalog): The library's OPAC is available over the internet and intranet, enabling users to

search for books, journals, and other materials available in the library. Users can check the availability of resources, verify whether they are currently issued to another person, and even place reservations for materials if they are checked out.

Circulation History: The system also allows users to track their circulation history, enabling them to review the books and resources they have previously borrowed.

RFID Technology for Issue and Return: The issue and return of library materials are handled efficiently using RFID technology, which helps streamline the process and reduces human error. This system ensures a faster and more accurate tracking of resources as they are checked in and out.

Overdue Fines and Notices: The KOHA software automatically calculates overdue fines for late returns, making the fine collection process seamless. It also generates overdue notices, reminding users to return borrowed items on time, ensuring better resource circulation and management.

There is a Standard Operating Procedure (SOP) regarding access to and maintenance of library.

6.1.2 - The effective leadership is reflected in various institutional practices such as decentralization and participative management

NLUO has an empowering and transformational leadership. The NLUO Act, 2008 has identified composition of the University in section 3 as Chancellor, Vice-Chancellor, General Council, Executive Council, Academic Council and the Registrar. Section 10 has identified the authorities of the University to include Finance Committee along with those mentioned earlier. At NLUO the leadership while maintaining accountability has ensured existence of trickle down management system allowing for complete decentralisation. The organogram (as attached) indicates the structural decentralisation as followed by the institution. All decisions at NLUO are taken in a participative and consultative manner where inputs from faculties are sought either through emails or during the periodic Faculty Meetings whose agenda is floated beforehand. NLUO has a very dynamic strategic plan which allows for mid-course correction as well as amendments and introduction of newer initiatives in furtherance of the larger University Plans.

NLUO's institutional strategic plan is directed at Student

IQAC has significantly contributed to growth of NLUO by supporting the following initiatives:

- 1. ISO Surveillance Audit:** The University is ISO 9001:2015 certified by Bureau of Indian Standards for providing undergraduate programmes, certificate programmes, post graduate and post graduate diploma programmes and doctoral studies related to law.
- 2. IQAC supported guest lectures and faculty seminars.** Mr. Subroto Bagchi a philanthropist and a start-up genius was hosted by NLUO under the auspices of IQAC. IQAC regularly conducts faculty seminars/ lectures for dissemination and exchange of ideas between the faculty members. Alongwith strengthening the research centres.
- 3. Promotion of Research and Publication:** As per the

7.2 - Best Practices

Context:Centre for Child Rights and Kutumb are carrying out research and collaborative activities with the intention of creating child friendly villages in the three adopted communities.

Centre for Child Rights has been one of the most active centres at NLUO. With the continuous support from the Central and State Governments and UNICEF, the CCR has managed to enlighten the child rights lobbies with its research and ability to generate a movement. With the recent focus of the world on importance of children visible through the Sustainable Development Goals and India's focus on issues pertaining to Baal Panchayats, Child Friendly Villages, and overall rights of children the CCR becomes even more relevant.NLUO's first Chief Minister's Chair Professor, Prof Biraj Swain joined NLUO in January 2024. NLUO is the first institution in India to be granted the position of Chief Minister's Chair Professor, sanctioned by the Government of Odisha.

Evidence of Success: The members of the community have supported NLUO in conducting data collection for research. The members have participated in discussions outlining their issues.

Challenges: Lack of trust amongst members of community leading to additional time being spent in building the trust.
