ABOUT THE CREDIT COURSE

This two credit course aims to explore the intersection of human rights and social justice, focusing on the legal, social, and policy frameworks affecting persons with disabilities, gender minorities, and other vulnerable communities. It examines key international and national human rights instruments, including the UN Convention on the Rights of Persons with Disabilities (UNCRPD), the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), and Indian constitutional provisions.

Through case studies and critical discussions, students will get an insight to analyze discrimination, social exclusion, and intersectionality while assessing the role of state and non-state actors in advancing equity and inclusion. The course aims to develop advocacy skills, policy analysis abilities, and a deep understanding of legal protections for marginalized groups. By the end, students will be equipped to engage in informed debates and contribute meaningfully to social justice movements and legal reforms in India and beyond.

COURSE OBJECTIVES

This course aims to:

- 1. To provide a comprehensive understanding of human rights principles and their intersection with social justice.
- 2. To analyze the legal, social, and policy frameworks that impact persons with disabilities, gender minorities, and other vulnerable groups.
- 3. Explore the role of international and national human rights mechanisms in promoting social justice.
- 4. Develop critical thinking skills to assess human rights violations and propose legal and policy solutions.
- 5. Encourage advocacy and empowerment strategies to promote inclusion and equity in society.

In this capacity, she is instrumental in implementing various initiatives aimed at the rehabilitation and empowerment of persons with disabilities.



Sri Rajive Raturi

Rajive Shri. Raturi is prominent disability rights advocate and legal expert, renowned for championing accessibility and inclusion in His landmark case, India. Rajive Raturi v. Union of India, culminated in a 2024 Supreme judgment Court that struck down nonmandatory accessibility reinforcing guidelines, accessibility as a fundamental right for persons with disabilities.



Dr.Gitanjali Ghosh

Gitanjali Ghosh is Dr. Associate Professor of Law at **Tezpur** University's Department of Law in Assam, India. Dr. Gitanjali Ghosh, has significantly contributed to disability rights through her research, teaching, and legal advocacy. She emphasizes rights-based a approach disability, to inclusion, focusing on accessibility, legal and empowerment. Her work supports policy reform and promotes awareness of the Rights of Persons with Disabilities 2016, Act. particularly in Northeast India.



Dr. Aditi Panda

Dr. Aditi Panda is a distinguished gender and disability rights activist based in India, recognized her for extensive contributions to promoting inclusivity and advocating for the rights of marginalized communities. Dr. Panda holds a Master's and Ph.D. in Social Sciences from the School of Studies. Women's Her pursuits academic have provided her with a profound understanding of the intersections between gender, disability, and social justice.

Dr. Tanwi Shams is an Assistant Professor of Law at National Law University Odisha (NLUO), specializing in Disability Law, Human Rights Law, and Intellectual Property Law. Dr. Shams has contributed significantly to disability rights discourse through her research and publications.
