Maximum Word Limit

• Short Articles: 4000-6000 words

• Long Articles: 8000- 10000 words

• Case Comments: 2500 words- 4000 words

• Book Reviews: 2500 words-3000 words

Authorship

- Co-authorship up to two authors is allowed.
- Academicians, professionals, and researchers are invited to submit their work.
