NOTIFICATION

Subject: Spot Admission Against Vacant Seats – Academic Year 2025–26.

1. For LLB, LLM, BALLB and BBALLB, spot round of admission is only for the candidates who have appeared in CLAT-2025 or NAIET-2025.
2. For applicants of NRIs category (BALLB and BBALLB) who have applied at NLUO for admission under NRI/NRIs/PIO/OCI category and are not yet offered a seat by the University.
3. It is compulsory to report the candidate in person for spot round of admission.
4. The candidates have to report on 27/09/2025 by 09:00 AM at NLUO for Spot Admission. Candidates reported after 09:00 AM will not be considered for spot round admission.
5. Since the seats are limited, it is not necessary that all reported candidates will get a chance for admission.
6. The admission will be offered on a merit basis on 27/09/2025 after verification of candidature and admission process will be completed on the same day.
7. The candidate has to deposit University fee through Demand Draft and complete document verification process on the same day. Therefore, candidates must come with a Demand Draft of requisite fees.
8. Demand draft should be in favour of “*Registrar, National Law University Odisha*”, payable at *Cuttack*.
