




ABOUT SPORTS COMMITTE

Course OBJECTIVES	 Understand the legal and regulatory frameworks that govern sports in India and globally. Analyze the role of key bodies such as the IOC, WADA and CAS. Interpret and draft sports-related contracts including player agreements, sponsorships, and broadcasting deals. Apply principles of dispute resolution and arbitration specific to sports law. Evaluate legal issues related to doping, matchfixing, player representation, and media rights. Engage confidently with legal practice in the sports industry as lawyers, agents, administrators, or consultants.

METHOD OF INSTRUCTION	Online through Zoom	
ATTENDANCE	Minimum 75% to be eligible for evaluation. Attendance shall be recorded after the completion of each session.	
EVALUATION	Participants will be assessed through a 100-mark Multiple Choice Question (MCQ) examination conducted at the end of the course. The minimum requirement for passing the exam shall be 50 marks out of 100, which if not obtained, the candidate shall not be issued with the certificate for the credit course. The mode of the test shall be online and shall be conducted in the vigilance of Committee members. The timings of the same shall be notified in the due course.

Module II	 Human Rights and Sports (2 Hours) The intersection of human rights principles and sporting activities. Protecting athlete welfare, freedom of expression, and non-discrimination. The role of the UN, IOC, and international charters in safeguarding rights.
Module III	 Understanding Sports Contracts (4 Hours) Essential elements of sports contracts: offer, consideration, and capacity. Common types: player contracts, sponsorship, image rights, and broadcasting deals. Dispute resolution and breach of contract in sports contexts.
Module IV	 Play Clean: Legal Frameworks on Doping (4 Hours) The World Anti-Doping Code and national anti-doping legislation. Testing procedures and sanctions. Case studies.

Module V	 Fair Play & Discipline: Governance and Accountability in Sport (4 Hours) Structures of sports governance and ethical codes of conduct. Internal disciplinary mechanisms and due process. Ensuring integrity: corruption prevention, transparency, and accountability measures.
Module VI	 Resolving Sporting Disputes (4 Hours) Mechanisms for resolution: arbitration, mediation, and negotiation. The role and jurisdiction of the Court of Arbitration for Sport (CAS). Case studies.
Module VII	 Intellectual Property in Sports (2 Hours) Trademark, copyright, and licensing in sports branding. Broadcasting rights, digital media, and commercial exploitation. Athlete image rights and protection against unauthorized use.


