Admission under Ward of Ex-Servicemen and Self

In addition to the above, 1% of seats reserved for Children/Widows of Personnel of the Armed Forces (Priority I to IX) including Para-Military Personnel (Only Priority I to V), in the following order of preference.

- Priority I : Widows/Wards of Defence personnel killed in action;
- Priority II : Wards of Defence personnel disabled in action and boarded out from service with disability attributable to military service;
- Priority III : Widows/Wards of Defence Personnel who died while in service with disability attributable to military service.
- Priority IV : Wards of Defence Personnel disabled in service and boarded out with death attributable to military service.
- Priority V : Wards of Ex-servicemen and Serving personnel, including personnel of police forces who are in receipt of Gallantry Awards.
 - a) Param Vir Chakra
 - b) Ashok Chakra
 - c) Maha Vir Chakra
 - d) Kirti Chakra
 - e) Vir Chakra
 - f) Shaurya Chakra
 - g) President's Police Medal for Gallantry /President Gallantry Medal for the fire services personnel
 - h) Sena Medal (Gallantry), Nau Sena Medal (Gallantry), Vayu Sena Medal (Gallantry).
 - i) Mention-in-Despatches
 - j) Police Medal for Gallantry/Gallantry Medal for the services
- Priority VI : Wards of Ex-Servicemen.
- Priority VII : Wives of
 - a) Defence personnel disabled in action and boarded out from services
 - b) Defence personnel disabled in service and boarded out with disability attributable to military service.
 - c) Ex-servicemen and serving personnel who are in receipt of Gallantry Awards.
- Priority VIII : Wards of Serving Personnel
- Priority IX : Wives of Serving Personnel

All such Candidates have to upload the Educational Concession Certificate to be issued by any of the following authorities on the proper letterhead.

- A. Secretary, Kendriya Sainik Board, Delhi
- B. Secretary, Rajya Zila Sainik Board
- C. Officer-in-Charge, Record Office
- D. 1st Class Stipendiary Magistrate
- E. Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

No other format shall be permissible. Proofs of the above category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lie of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered.
