FROM THE REGISTRAR'S DESK



Project KHOJ

The KHOJ (Know Your High Court Judges) Project aims to prepare a comprehensive dataset on all High Court judges. The dataset of KHOJ project was launched on 17 September at the National Law University Odisha by Chief Justice of India U.U. Lalit, Justice D.Y. Chandrachud, Justice M.R. Shah and former Orissa High Court Chief Justice Dr S. Muralidhar.



Prison Advocacy Project

The Prison Advocacy Project is a transformative initiative funded by the Azim Premji Foundation. Focused on systemic reform, the project addresses pressing issues within the incarceration system, including prisoner rights, legal aid for undertrial prisoners, and rehabilitation strategies. The project is envisioned to improve access to justice, promote prisoner welfare, and develop sustainable frameworks for advocacy and reform.



RESEARCH PROJECTS

Start-Up Odisha

The main objective of the MOU is to provide all types of legal assistance to Startup Odisha, conduct seminars, workshops, Startup Weekends, training Programmes in collaboration with Startup Odisha, Collaborative research and teaching, research findings, and publications. The terms and conditions of the MOU is executed through Lextech – Centre for Law, Entrepreneurship and Innovation, NLUO.



Women Safety Audit with NCW

The National Commission for Women along with NLUO is conducting a Women Safety Audit project in Asansol, a city situated in West Bengal. The audit aims to understand what makes public spaces safe, identify reasons for poor safety, and create a roadmap for building secure cities by proactively addressing these issues. The purpose of this study is to evaluate the safety concerns encountered by women within the city. The findings will be used to make recommendations for enhancing law enforcement efforts, improving infrastructure design, and strengthening community participation.



& OTHER COLLABORATIONS

Tobacco Control Project

NLUO in collaboration with the International Union Against Tuberculosis and Lung Disease is working on a policy intervention project titled 'Supporting stronger and evidence-based tobacco control initiatives through capacity building and strengthening laws, policies and institutional mechanisms with multi-stakeholder engagements towards tobacco-free India'. The objectives of the project inter alia include strengthening tobacco control laws in Odisha, supporting the Odisha government in adopting stronger policies and capacity building of stakeholders.



Addressing Domestic Violence in Odisha

In July, 2023, National Law University Odisha, Cuttack entered into an agreement with the Netherlands Embassy to implement a project titled Addressing Domestic Violence in Odisha through Institutionalised Domestic Violence Response Protocols. The Project is funded by the Human Rights Fund. The project is for a period of two years and is led by Prof. Rangin Pallav Tripathy and Assoc. Prof. Suman Dash Bhattacharya. The project aims at establishing institutionalized domestic violence response protocols in the state of Odisha to enhance the victims' access to justice.





LIFE AT NLUO

The campus life at NLUO is enriched by a series of vibrant flagship events that celebrate community, talent, and inclusivity. Kairaan, the inter-university cultural fest, showcases diverse events, student entrepreneurship, and culinary talent over three engaging days. NLUO INITIATIVES

NLUO BOSE & MITRA & CO. INTERNATIONAL MARITIME ARBITRATION MOOT (IMAM)

The Moot Society's flagship event - International Maritime Arbitration Moot, currently the biggest maritime arbitration moot in India, is organized in March annually. We, at NLUO, have chosen Maritime Law as the subject matter to complement the maritime operations in Odisha and consequently, promote intellectual discourse in the field of Maritime Law. The NLUO-IMAM has created a niche for itself as it is the first in India and third in the world to have maritime law as its principal subject area in mooting. We have successfully hosted the previous editions with the support of Bose & Mitra & Co. as our title sponsors and EBC and SCC Online as our knowledge partners.

NLUO-PHFI PUBLIC HEALTH LAW NATIONAL VIRTUAL MOOT COURT COMPETITION

While the Covid-19 pandemic has put a spotlight on the subject, there is a need for broader engagement with administrators, academicians, lawyers, and law students across the country to critically analyze the role of law in making health a realizable goal and ensuring distributive fairness in the allocation of critical health infrastructure. With an aim to reach out to law students across the country and make them think and research about various nitty-gritties of byzantine legal rules and principles that form the bedrock of the public health apparatus, NLUO is the proud host of PHFI-NLUO Public Health Law National Virtual Moot Court Competition.

GAJE-NLUO MEDIATION AND NEGOTIATION CONCLAVE

The NLUO Centre for Mediation and Negotiation organizes the "GAJE-NLUO Mediation and Negotiation Conclave" with the support and sponsorship of the Global Alliance for Justice Education (GAJE) and in collaboration with the NLUO Alternative Dispute Resolution Board in order to create awareness and promote the highly efficient mode of mediation. This Conclave is holistically designed to meet the expectations of participants, primarily students from various parts of the country, by providing opportunities to learn and enhance their skills in mediation and negotiation. The learning techniques employed during the Conclave include Experiential Learning, Experience Sharing, Brainstorming, Group Discussions, and Lecturing, ensuring a blend of theoretical and practical knowledge. The NLUO Mediation Cell at the Centre for Mediation and Negotiation aligns with Sustainable Development Goal (SDG) 16 of the UN, which corresponds to GAJE's mission of achieving justice through legal education.

NLUO BRITISH PARLIAMENTARY DEBATE

The NLUO British Parliamentary Debate (NLUO BPD) is the flagship debating competition organized by the Literary & Debating Committee, NLUO. The 2023 edition was the biggest one yet. NLUO hosted more than 190 participants both nationally and internationally. This included 60 institutional and cross teams and adjudicators. The Core Adjudication Panel (CAP) for the Sixth NLUO BPD consisted of some of the most revered debaters in the Indian circuit, some of whom actually broke in the 2021 Korea World Universities Debating Championship.

LEXATHON: THE TECH LAW CONCLAVE

Lexathon - The Tech Law Conclave, is a flagship event organised by LexTech - Centre for Law, Entrepreneurship, and Innovation. Spanning over a course of three days, this conclave is a culmination of different events aiming to promote academic and legal discourse in areas of technology law, such as AI, Online Gaming, FinTech, Data Privacy, and TMT. The first edition of the conclave was organised in March 2025, which witnessed participation from students across law colleges. This included a paper presentation competition and a panel discussion with industry experts to brief students on the real-world implications of these laws.

RECRUITMENT PROCESS

1. Initial Communication

The Recruitment Coordination Committee, NLUO, shall send invitations to recruiters along with the placement brochure and relevant information. Alternatively, an organisation may approach the Recruitment and Coordination Committee by writing to recruitment@nluo.ac.in.

2. Pre-Placement Talks

Recruiters are invited to organize Pre-Placement Talks at the University for interested students. During these sessions, valuable information such as organizational profiles, career advancement opportunities, compensation packages, and more can be shared. These presentations can take place ahead of the Pre-Interview Screening process.

3. Pre-Interview Screening

Recruiters have the option to carry out a Pre-Interview Screening, which may include group discussions or written tests at any point before the actual interview day. Recruiters have the flexibility to establish their own screening policies to shortlist candidates. In instances where a Recruiter doesn't specify a particular Pre-Interview Screening method, the curriculum vitae of all interested students will be shared with the Recruiter.

4. Final Interview

Following the conclusion of the Pre-Interview Screening, the Recruiter will prepare the Final Interview List and share it with the RCC at least 48 hours before the scheduled interview, along with a list of waitlisted candidates. If any selected applicant from the Final Interview List is unavailable for the interview, the Recruiter may choose to interview waitlisted candidates if deemed appropriate. If the Recruiter does not have a Pre-Interview Screening procedure, the list of interested students will automatically serve as the Final Interview List.

5. Disclosure of Offers

The RCC will announce the results collectively at the end of the day to guarantee impartiality among recruiters. Recruiters must reveal the outcomes of their Final Interviews and any offers extended to applicants solely through the RCC, and this information will be conveyed in a sealed envelope.
