- 4. Bills will be settled within 15 working days from the date of submission.
- 5. All the payments will be made in Account Payee Cheques only in favour of the travel agency.
- 6. NLUO will not have any liability arising out of any accident involving the car whether or not the same was caused due to negligence of the driver.
- 7. In case of breakdown of the hired vehicle a suitable substitute vehicle must be provided immediately by the service provider.
- 8. The condition of the vehicle should be well maintained to keep it road worthy in all the seasons.
- 9. Parking fees, if any, shall be paid by the contractor which will be reimbursed by NLUO along with the payment of the bill subject to production of the documentary evidence and countersigned by the controlling officer.

- 10. No other charges towards maintenance of car, garage, and major/minor repairing charges, servicing charges will be borne by NLUO.
- 11. Service tax, if any, will be applicable as per Govt. Rules.
