

## **Notification for admission to B.A. LL.B. (Hons.) / B.B.A. LL.B. (Hons.) / LL.M. Programme for the Academic Year 2019-2020 under Foreign Nationals/NRI/NRI Sponsored Category**

Out of the total 120 seats of B.A.LL.B. (Hons.) and 60 seats for B.B.A.LL.B. (Hons.) Programme, 15 Seats (10 in B.A.LL.B. & 5 in B.B.A.LL.B.) are allotted to NRI/NRI sponsored candidates and 6 seats (4 in B.A.LL.B. & 2 in B.B.A.LL.B.) are allotted to Foreign Nationals. The unfilled seats in Foreign Nationals Category will get converted to NRI/NRI Sponsored Category and to General Category subsequently.

The applications for admission to B.A.LL.B.(Hons.) / B.B.A.LL.B.(Hons.) Programmes for the Academic Session 2019-2020 under Foreign Nationals / NRI / NRI Sponsored Categories need to be sent directly to the University through Speed Post only, along with the duly filled in application form, other relevant documents and prescribed fees etc. An advance copy of the same can be sent to [admissions2019@nluo.ac.in](mailto:admissions2019@nluo.ac.in)

The candidates under Foreign National Category shall be admitted directly on the basis of their 10+2 / Intermediate marks. However, applications under NRI / NRI Sponsored Category shall be considered for admission in case the candidate had appeared for CLAT 2019 under NRI/NRI Sponsored category. They shall send the filled in application form along with the copy of the admit card of CLAT 2019, other relevant documents and prescribed fees. They shall be admitted as per their Rank in CLAT 2019, depending upon the vacancies.

Candidates of the above mentioned categories shall fulfil other requirements regarding age and qualifications as per CLAT-2019 and NLUO eligibility Regulations. The merit list of Foreign Nationals will be determined on the basis of their 10+2 marks. If there is a tie, then the marks of 10th standard will be taken into consideration. If still there is no change in rank then, the higher in age shall get preference or in case of need the final admission will be done based on a lottery.

Candidates who wish to apply under Foreign Nationals Category / NRI / NRI sponsored category shall submit the duly filled in application form which can be downloaded from our Website i.e. [www.nluo.ac.in](http://www.nluo.ac.in) with all supporting documents along with DD for Rs. 20,000/- drawn in favour of Registrar, National Law University Odisha, payable at Cuttack. The filled in application and other documents must reach the undersigned in sealed envelope on or **before Saturday, 22<sup>nd</sup> June 2019**. Selected candidates should complete the admission formalities by paying required fees on the scheduled dates to be announced in the University Website: [www.nluo.ac.in](http://www.nluo.ac.in).

This amount of Rs.20,000/- is not refundable but adjustable in the fee payable by the candidate. ***The said amount will be forfeited in case the candidate is shortlisted/ called for admission but not reporting for admission as on schedule.*** However, Rs. 18,000/- will be refunded after a deduction of Rs.2,000/-towards administrative charges, in case she/he is not getting shortlisted for admission at NLUO, Cuttack. Once the candidate is admitted under the Foreign Nationals / NRI / NRI sponsored category the admission will not be converted into any other category subsequently.
