

Prof. Amita Dhanda is a Professor of Law, at NALSAR University of Law, Hyderabad. She teaches Administrative Law, Law and Poverty, Law and Literature and Judicial Process.

Prof. Dhanda joined NALSAR after a fifteen year stint on the Research Faculty of the Indian Law Institute, Delhi. She has written extensively on the legal position of persons with mental disability. Legal Order and Mental Disorder, her book on the legal status of persons with mental illness is a pioneering effort in the field. The Government of India and the Supreme Court of India have utilized her services to suggest far reaching legal and policy reform in the field of disability rights. She is assisting the Government of Gujarat in formulating a rights sensitive mental health law. Her research expertise has been drawn upon by international and national institutions such as the WHO, UNICEF, NHRC, NCW, NIMH.

Professor Shashikala Gurpur is the Director of Symbiosis Law School Pune since 2007.

She is a distinguished academician and orator having presented more than 200 invited lectures, workshops and seminars across India, Thailand, US, UK, Ireland, Germany, Australia, Canada and UAE. She has an outstanding career with a wide range of experience in teaching, research and industry. Dr. Gurpur has been a member of the Law Commission of India. DR. APARNA CHANDRA, Associate Professor of Law at National Law School Of India University Bengaluru.

She researches and writes on constitutional law, human rights, gender and the law, and judicial process reform. Her current research focuses on rights adjudication by courts, gender and the law, and empirical legal studies. In collaboration with the Centre for Reproductive Rights, New York, She is undertaking a study on legal barriers to accessing safe abortion services in India. Under the aegis of a University of Chicago funded project. She was also part of a European Research Council funded project by the Israel Democracy Institute on fundamental rights adjudication in various jurisdictions around the world. She is a national co-convenor of the Indian Feminist Judgments Project. She is an on-going Member, Committee appointed by the Delhi High Court to study the working of the Vulnerable Witness Deposition Complexes in Delhi. She has worked with the government and judiciary on various judicial and legal reform initiatives, and has collaborated with various human rights organizations on research and advocacy projects. Prof. C. Raj Kumar is the founding Vice-Chancellor of OP Jindal Global University, Sonipat, Haryana, India, and the Dean of the Jindal Global Law School. He works in the fields of human rights and development, comparative constitutional law, terrorism and national security, corruption and governance, law and disaster management, legal education and higher education.

Professor Kumar has held consultancy assignments in the field of human rights and governance. He has been a Consultant to the United Nations University (UNU), Tokyo; United Nations Development Programme (UNDP); UN Office of the High Commissioner of Human Rights, Geneva; and the International Council for Human Rights Policy (ICHRP), Geneva. He has advised the Commission to Investigate Allegations of Bribery or Corruption (CIABOC) in Sri Lanka and the National Human Rights Commission (NHRC) in India on issues relating to corruption and good governance. Professor Kumar is an Attorney at Law and is admitted to the Bar Council of Delhi, India and the Bar of the State of New York, USA.

Currently, Prof. MRK Prasad is Principal of V.M. Salgaocar College of Law. Where he has taught Contracts, Constitutional Law, Law of Evidence, Negotiation and Dispute Resolution.

Dr. Prasad is a leading expert in clinical education in India and the first recipient of Vanderbilt-Fulbright Scholarship in Clinical Legal Education. He is instrumental in establishing and functionalizing India's first legal aid set-up being run by a law college. For this initiation V.M. Dr. Gautam Bhan is a faculty member at the Indian Institute for Human Settlements. He works and teaches politics of poverty, inequality and development in Indian cities with a focus on housing, social security, governance and urban and planning theory. He is also the spokesman for LGBTQ+ rights and one of the petitioners in the legal battle to decriminalize homosexuality in India. Prof. Ved Kumari's areas of primary academic interest are juvenile justice, criminal law, gender discrimination, clinical education, and judicial education. She introduced an innovative full semester course in University of Delhi as part of Course Work for research scholars on 'Andragogy – the Art of Teaching Adults' aimed at training the future law teachers in the adult teaching methods and improving learning of students. She headed the Delhi Judicial Academy as its Chairperson during 2009 - 2011. She is the first and perhaps the only woman academic to hold such a prestigious position. She introduced participatory learning with a range of innovative participatory teaching methods in judicial training and organized two Training of Teachers Workshops to training judicial officers in the art of teaching. The Village Immersion Programme for Judicial Officers is a pioneer programme evolved and introduced by her in the One-year Training Schedule for the newly recruited judicial officers to expose them to various social issues like poverty, gender discrimination, education, etc. at the grass root. She also conceived and

successfully directed the first and so far the only E-course on Judicial Ethics and Conduct for judicial officers in collaboration with the Commonwealth Judicial Education Institute, Canada. Prof. Yogesh Pratap Singh is a Professor of Law and currently the Registrar at **Prof. Yogesh Pratap Singh** National Law University, Odisha. Prior to joining NLUO in 2009, when it was established, he was part of the founding team of KIIT Law School, KIIT University, Bhubaneswar. His doctoral thesis titled "Contribution of Dissenting Opinions of Indian Supreme Court Judges to the Indian Legal System: A Critical Evaluation" is recognized as a significant contribution to the understanding of voting patterns of judges in the Supreme Court of India. He participated in the 39th Annual Session on International Human Rights Law organized by International Institute of Human Rights (IIHR) Strasbourg, France. Dr. Yogesh has also been part of Ciedhu programme in France conducted for University Teachers. Dr. Singh has also worked as a Legal Researcher in the Rural Litigation and Entitlement Kendra (RLEK), Dehradun. He has presented numerous papers on constitutional, social and legal issues at various national and international seminars. He constantly writes in the field of law in reputed law chronicles, national and international law journals. Prof. Rita Ray, Adjunct Professor at NLUO.

Rita Ray has an experience of forty years in academics and consulting. Her academic profile includes teaching as a full-time faculty of Sociology at Utkal University, India since 1975. Born on 31st March 1951, she is currently the senior-most female Professor, in service, in the state today. She was also the Vice chancellor (in-charge) of Utkal University for a brief, but intensely challenging, period. She has been a Professor (Plan) from 1994 onwards and has lectured at many prestigious universities in India and abroad. She has been the Head of the Department (Sociology) for multiple terms and has implemented far-reaching academic and administrative contributions to the department. She has introduced numerous courses and electives in the department: A special mention, here, should possibly made of her pioneering role in successfully introducing and popularizing Gender studies in the University, as well as in the State. She has also been a part of numerous accreditation teams and interview boards of the University Grants Commission (UGC), Union Public Services Examinations (UPSC), National Assessment and Accreditation Council (NAAC) etc. Prof. Ray has guided and awarded close to 20 Ph. D theses, mostly pertaining to issues of Displacement, Rehabilitation and Gender, and has published extensively in national and international journals.. Dr Arjyalopa Mishra, is currently an Asst. Professor of Management at NLUO. Her research interests are Social psychology, positive organizational behavior and organizational psychology and human resource management. Dr. Rangin Pallav Tripathy



Dr. Rangin Pallav Tripathy has been teaching at National Law University Odisha since 2010 and works in the area of constitutional governance, civil liberties, criminal law and human rights. His current research focuses on the functioning of institutions within constitutional democracies and the way they affect realization of democratic rights.

He was a Fulbright Post-Doctoral Research Scholar at Harvard Law School (2019-2020) where he researched on the competing methods of appointing judges in democracies. His doctoral thesis is the first work of its kind in India on performance evaluation of judges in the higher judiciary. He has completed two research projects funded by the Department of Justice, Government of India in the area of judicial reforms. Dr. Suman Dash Bhattamishra



Dr. Suman Dash Bhattamishra joined National Law University Odisha in 2011 when it was still in its foundational years. At the university, I have taught subjects like International Criminal Law, Access to Justice, Criminal Law and Gender Laws.

Her research work is primarily in the areas of Gender Rights, Access to Justice, Criminal Law Reforms, Juvenile Justice and Rights of Victims in the justice delivery mechanism. I also take interest in Legal Theory.

She played a similar role in establishing the Community College for Paralegals at NLUO.

Dr. Abhik Majumdar, is currently working as Asst. Professor of Law at NLUO. He has gained his first degree in law from the National Law School of India University (NLSIU), Bangalore. He followed it up with a thesis-track LLM from the National University of Singapore (NUS); and then a PhD from the National Law University Odisha (NLUO), Cuttack. Prior to joining NUS, he was associated with several research bodies, NGOs, law firms, and even a music archive as legal officer for a project partnered with the Smithsonian Institution. His principal research interests concern jurisprudence and legal theory. His PhD thesis engages with Hohfeld's schema of jural correlatives, and its conceptual and heuristic utility. And his LLM dissertation examines Hart's legal positivism and whether it sustains its descriptive goals. He has also worked on other aspects of legal theory, including the jurisprudence of the ancient legal treatise Kauțilya's Arthaśāstra. His involvement with non-theoretical aspects of law extends to the law of sedition; law and religion; WTO law; the law of agriculture; and the theory of terrorism law. He has published in several prestigious international journals such as the Journal of Indian Philosophy; South Asian History and Culture; and the Australian Journal of Asian Law.
