
Master's course work, they have much deeper grasp over the subjects coupled with their practical experience from the field as well as research and writing skills.



The Course comprises 03 Foundation/Compulsory Papers (three credits each), 06 Optional/Specialisation Papers(two credits each) to be notified in each semester and Dissertation (3 credits). The specialisations offered are:
