It is submitted that learning of Undergraduate studies as well as Postgraduate studies be liked to these centres. A student has to work in 10 Semesters in 10 centres of their choice. This is going to bring a blend of service to the people in need of legal services & business related laws, practical learning.

There are 8 seminar courses taught at present. These seminar courses will have emphasis on the application of laws to the real situations. For example, a student doing a seminar course on Child Right will be appearing before the Juvenile Justice Court under the supervision of their teachers & the panel of University Advocate working for legal aid centres.

Similarly, they will also take up research work relating to child labours in various sectors of the industry or they may do some research on children in need of care & protection by visiting the organisations implementing the same.

A student taking of contract law and management seminar course will be required to go through the some of the contracts relating to infrastructure or sale of machinery or goods etc. and analyse the way it has been drafted and any improvement that may be incorporated. Students will also be required to draft some contracts under the supervision of the teachers.

In order to facilitate this efforts are being made to establish contact with Infrastructure Development Corporation of Odisha (IDCO) and other industries situated in Odisha.
