The Academic Council after detailed deliberations approved the introduction of Agricultural Law Course as an Optional Course and recommended to the Executive Council establishment of the Agricultural Law Centre. Prof. M.P. Singh observed that once the Course Outlines have been prepared, the same should be sent to him so that he can forward it to some WTO experts for their expert comments. Prof. V.Vijaya Kumar suggested that the Course Outline should also be sent to NLSIU, Bangalore who are offering similar one credit course. Prof. V.Vijaya Kumar also suggested that the Agriculture Centre can make us a leader in Legal Education if we can conduct some executive training workshops. We should also offer Training and Innovation Management

Programmes for the Agro-industry. In the field of Bio-technology we should try to give training to the scientists after collaborating with the Department of Bio-technology.

#### Agenda Item No:-8

- 1. The Vice-Chancellor informed the Academic Council about the efforts which have been made to set up a Chinese Law Centre at NLUO. The Vice-Chancellor informed the Academic Council that the Centre would conduct Chinese & Comparative Law Researches, organise Chinese Law Seminars & Conferences, provide Chinese Law Training to Lawyers and Professionals etc. The Vice-Chancellor also informed that Prof. Kam C. Wong would be visiting University sometime in April to conduct special lecturers on the Chinese Law and finanlise the other details of the Centre. Prof. V.Vijaya Kumar welcomed the proposal and said that it is for the first time in India that a National Law University/Law Department is thinking of offering courses in Chinese Laws which are an urgent need of our time. On the suggestion of Prof. V.Vijaya Kumar, the Academic Council authorized the Vice-Chancellor to contact Asian Law Institute, Singapore for collaboration in this matter. It was also decided that NLUO would become member of ALI. The Academic Council after detailed deliberations recommended to the Executive Council establishment of Chinese Law Centre and autorised the Vice-Chancellor to decide the credit of Chinese Law Course depending upon the number of lectures to be delivered by the experts.
- 2. Prof. K. Mahajan raised the issue that since the current semester is short one, can we think of skipping mid-semester examination as one week of teaching would be lost due to examination and there would be low attendance for few days prior to Examination. The Council after detailed deliberations did not accept the request and Prof V. Vijya Kumar observed that we should set such questions that students' rather than fearing examinations enjoy taking the examinations.
